1. RULES:

- 1.1 The Regatta will be governed by the rules as defined in The Racing Rules of Sailing 2021-2024 and the International Sunfish Class Association Rules.
- 1.2 Rule 40.1 applies at all times while afloat.

2. SAILING INSTRUCTIONS

- 2.1 SIs will be available on or before Friday, May 17, 2024
- 2.2 RRS 63.7 will be deleted and replaced with: "In case of conflicts between the NOR and the SI, the SI shall govern."
- 2.3 Sailing Instructions will be available online only, not printed

3. ELIGIBILITY, ENTRY AND FEES:

- 3.1 The event is open to boats of the International Sunfish Class.
- 3.2 Eligible competitors and boats may enter by completing the online registration together with the required fee.
- 3.3 Registration closes 5/18/2024 @ 0900.
- 3.4 The registration fee is \$30. No on-site registration will be available. If you can't register online please email [BUSCSebago@gmail.com](mailto:BUSCSebago@gmail.com) Registration link to come.
- 3.5 The entry fees will include a Regatta t-shirt for registrations completed and paid for on or before Tuesday, May 14th at 11:59PM EST. Registrations received after this time will not be guaranteed a regatta t-shirt.

4. SCHEDULE:

- Saturday: May 18
- 1000-1200 : Check in
- 1300 : Skipper's meeting
- 1400 : First Signal for first race of the day. Subsequent races back to back.

5. VENUE:

The regatta will take place on Jamaica Bay.

## 6. SCORING

6.1 The Low Point Scoring System, RRS Appendix A2, shall apply. One race will constitute a regatta.

6.2 When fewer than 4 races have been completed, a boat's series score will be the total of its race scores.

6.3 When 4 or more races have been completed, a boat's series score will be the total of its race scores, excluding its worst score.

## 7. INSURANCE

It is the competitor's responsibility to have adequate third-party liability coverage in effect for the duration of the Regatta. Insurance will not be checked at registration. Participation in the Regatta is the competitors' or competitors' parent's confirmation of having such insurance in place.

## 8. WAIVER
