# **1 ORGANIZING AUTHORITY**

The Organizing Authority is the Storm Trysail Club, Chesapeake Station.

#### 2 RULES

- 2.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 2.2 2014 HPR Rules, ORC Rules and IRC Rules apply to respective classes.

#### **3 ADVERTISING**

There will be no restrictions on competitor advertising.

## 4 ELIGIBILITY AND ENTRY

The regatta is open to all boats with a valid 2014 HPR, IRC or ORC Club certificate. To Enter: <u>www.yachtscoring.com/emenu.cfm?eID=1058</u>.

## 5 CLASSIFICATION

There will be no classification requirements.

#### 6 FEES

Entry fees will be \$10.00/foot, LOA (rounded down to nearest whole foot) if paid before October 1, 2014 and \$12.00/foot, LOA after October 1, 2014.

#### 7.2 Number of races:

## Friday 2 (one long race, with scoring gate for short race)

Saturday: up to 4

Sunday: up to 3

- **7.3** The scheduled time of the warning signal for the first race each day is 10:30.
- 7.4 No Warning signal shall be made after 1530 on Sunday.

# 8 MEASUREMENTS AND CERTIFICATES

- 8.1 Measurements for HPR and IRC certificates shall be submitted for processing to US Sailing no later than October 24<sup>th</sup>.
- 8.2 Data for ORC Club certificates shall be submitted online at <u>www.orc.org/index.asp?id=25</u> no later than October  $24^{th}$ .

# 9 SAILING INSTRUCTIONS

The Sailing Instructions will be available after 1700 on October 30th at registration, as well as on the regatta website.

## 10 VENUE

Racing will occur on the Chesapeake Bay off the mouth of the Severn River.

# 11 COURSES

- **11.1** The coastal race will use a combination of drop marks and government marks. The Sailing Instructions will list the marks that may be used, and the method of describing the course from the signal boat.
- **11.2** It is intended that the Coastal race consist of two races: a long race of 4-6 hour duration, with a scoring gate at about 1-3 hours into this race.
- **11.2** Mark descriptions and positions for the Coastal race may be available on the regatta website prior to the Sailing Instructions.
- **11.3** Drop mark courses for Saturday and Sunday will be described in the Sailing Instructions. The approximate length of each leg will be approximately 1.0 1.8 nm as appropriate for races of 1 1.5 hour duration.

## 12 PENALTY SYSTEM

RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

## 13 SCORING

- **13.1** The low point scoring system in Appendix A shall be used.
- **13.2** Two races are required to be completed to constitute a series.
- **13.3** The long portion of the Coastal race score will be weighted as 1.5 times the scores for the drop mark races, and the scores taken at the scoring gate will be weighted 1.0.

## 14 PRIZES

Trophies will be awarded to the top three finishers in each class of the event, except the HPR 1 Class will also award trophies to the top three finishers in IRC scoring.

#### 15 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
