CRUISING BOATS

For IRC, PHRF, Level, and One Design Racer/Cruiser and Non-Spinnaker Boats

NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*, the current IRC Rules, the current PHRF Regulations as administered by the YRA of LIS, and Level or One-Design Class rules.
- 1.2 Boats shall observe the Minimum Equipment Recommendations of YRA of LIS, Race Category C.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Sections A, B and D of Appendix T will apply, as changed:
 - (i) T1 is changed to: The first two sentences of rule 44.1 are changed to: 'A boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 in an incident while *racing* or rule 31. However, when she may have broken one or more rules of Part 2 in an incident while in the *zone* around a *mark* other than a starting *mark*, her penalty shall be a Two-Turns Penalty.'
 - (ii) T2.2 is changed as follows:
 - (a) 30%, if taken before the protest time limit and before the beginning of arbitration or a protest hearing involving the incident.
 - (b) 40%, if taken before the beginning of a protest hearing involving the incident.

2 ENTRIES

- 2.1 Eligible boats may enter by registering online at Yacht Scoring: http://www.yachtscoring.com or on approved entry forms received by the Larchmont Yacht Club front desk not later than 1700, Wednesday, July 9, 2014.
- 2.2 The Entry Fee is \$100.00
- 2.3 There will be IRC and PHRF divisions, and, at the discretion of the race committee, separate divisions for Level and One-Design may be assigned. Divisions may be subdivided into classes.
- 2.4 For those not sailing Level or One Design, entries must be accompanied by a valid PHRF or IRC rating certificate. PHRF certificates from other areas will be adjusted to conform to the YRA of LIS. IRC certificates do not need to be endorsed.

3 SAILING INSTRUCTIONS

- 3.1 Sailing Instructions will be available at least one week before the regatta on the internet at: www.larchmontyc.org and http://www.yachtscoring.com or at the Larchmont Yacht Club front desk or the Hospitality Desk on the day of the event.
- 3.2 Scratch Sheets will be available at the front desk after 1800 Friday, July 11, at the Hospitality Desk during the event and, and from a committee boat prior to the first warning signal of the day or online at Yacht Scoring.

4 COURSES, RACING AREA AND RACES

- 4.1 The racing area will be in the waters off Larchmont Harbor.
- 4.2 The courses will be as described in the Sailing Instructions
- 4.3 The warning for the first division will be at 1055 each day.

5 SCORING

- 5.1 One completed race constitutes a series.
- 5.2 If fewer than five races are completed, a boat's series score will be the total of her race scores. If five or more races are completed a boat's series score will be the total of her race scores excluding her worst score subject to rule 90.3 (b).
- 5.3 PHRF and CRF time allowances will be computed using Time on Distance. For IRC the boats rating allowance will be applied as a factor of the elapsed time.

6 PRIZES

Series prizes for First, Second and Third places in each division will be awarded on Sunday, July 20 after the completion of racing on the front lawn of the Larchmont Yacht Club.

7 GUEST MOORINGS AND CLUB PRIVILEGES

- 7.1 Guest moorings will be available on a first come basis at no charge. Reservations are required. Please contact Marine Facilities at 914-468-7742.
- 7.2 The privileges of the Club for Race Week will be extended to owners and crews

1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing* and the Wooden Boat Regatta Series Rules Addendum A
- 1.2 Boats shall observe the Minimum Equipment Recommendations of YRA of LIS, Race Category C.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.

2 ENTRIES

- 2.1 Eligible boats may enter by registering online at Yacht Scoring: www.yachtscoring.com, or on approved entry forms received by the Larchmont Yacht Club front desk not later than 1700, Wednesday, July 9, 2014
- 2.2 The Entry Fee is \$85.00.
- 2.3 At the discretion of the race committee separate divisions may be assigned. Divisions may be divided into classes.
- 2.4 CRF ratings will be entered as sec/mile.

ADDENDUM A TO THE NOTICE OF RACE WOODEN BOAT REGATTA SERIES RULES

1 RULES

- 1.1 All yachts must have a current CRF Certificate.
- 1.2 Yachts may have only one valid CRF Certificate at a time, and may submit only one rating certificate per season .Other limitations on obtaining certificates may apply in the CRF rules.
- 1.3 For the purposes of rules 10, 13, 14, 15 and 16, the definition of keep clear is changed to: Keep Clear: One boat keeps clear of another when she is more than one of her hull lengths away from the other boat and the other boat can sail her course with no need to take avoiding action, and when the boats are *overlapped* on the same tack, the *leeward* boat can change course in both directions without immediately making contact with the *windward* boat.

2 ELIGIBILITY

Eligibility is determined by the Notice of Race. Yachts must meet those requirements in addition to these Classics Boat Rules.

3 CLASS DESIGNATIONS

3.1 Classes

CRF Vintage and CRF non-Vintage yachts shall not be scored together.

3.2 **CRF Vintage Design**,

Construction and materials

- a. Full keeled (or keel-centerboard), split-keel and rudder.
- b. Designed in or before 1970
- c. Steel/aluminum and wooden yachts
- d. Built utilizing original materials and methods as designed
- e. Minimum of 30' LOA, full decked (reasonable cockpit excepted), with accommodations.
- f. Fixed ballast
- g. Rigged with aluminum or wooden spars

Sails (permitted):

Woven fabric (Canvas, Nylon, Dacron as well as more contemporary woven fabrics such as Vectran and Hydranet). Prohibited are sails such as those utilizing advanced shaping technologies (3DL or similar), laminate or composite construction, or materials such as, but not limited to, Mylar, Kevlar, Spectra, Carbon Fiber, etc.

Manual Power/Hydraulic Winches:

For all yachts in the Classic Divisions whose LOA is greater than or equal to 70 feet, Rule 52 is deleted. Rule 52 shall still apply to Classic yachts with a LOA less than 70 feet. A Classic yacht with a LOA of less than 70 feet racing in contravention of Rule 52 will be

designated to compete in the "CRF Non-Vintage" Division.

CRF Non-Vintage

Yachts that evoke the pre-1970 design and/or spirit of Vintage yachts, but do not otherwise meet all of the above criteria for a Vintage yacht.

3.3 Spinnaker Classes

- a) For CRF rated yachts, separate spinnaker and non-spinnaker classes may be established as long as there is a minimum of four comparable yachts in each class.
- b) All boats shall race in non-spinnaker classes unless there is a minimum of <u>four comparable</u> yachts in both the spinnaker and non-spinnaker classes (minimum of 8 yachts).

4 LIMITATIONS ON HEADSAILS & EQUIPMENT

- 4.1 A whisker pole or spinnaker pole maybe used to wing out a jib on the side opposite the main boom as long as no other sail, including a staysail, is set in the fore-triangle. Whisker or spinnaker poles shall not exceed 110% of the yacht's J-measurement.
- 4.2 Poles must be fixed at the mast while in use in accordance with Rule 50.2.
- 4.3 Spinnakers and Headsails are defined in accordance with Rule 50.4
- 4.4 Non-Spinnaker Classes Sail Limitations:
 - a) Only one jib shall be carried in the fore-triangle at one time: i.e., drop one sail before setting another. This changes Rule 50.1.
 - b) Bona fide double headsail rigs (defined as being properly rigged, including permanent fixed points on deck and on the mast) may carry a fore-triangle staysail that is hanked on to the inner forestay. All headsails must be tacked on the centerline of the boat.
 - c) All sails set in the fore-triangle must be hanked on for the full length of the stay (except fixed-stay roller furling sails). Flying a headsail on its tack and head only, or on an internal wire luff, is not permitted.
 - d) Mizzen staysails are permitted.
 - e) All yachts shall be limited to sail area as defined in their CRF certificate. This includes a 150% max LP for headsails unless otherwise rated in which case a yacht may fly a headsail up to their max rated LP on their certificate.

4.5 Spinnaker Classes

Spinnaker classes are exempt from the above non-spinnaker sail limitations, but must comply with sail material and all other listed rules and eligibility requirements.

5 SCORING

- 5.1 CRF Ratings converted to sec/mile will be used for scoring.
- 5.2 CRF non-spinnaker (base) ratings will be used unless a separate spinnaker class is specified.
- 5.3 CRF Spinnaker ratings shall not be scored together with CRF non-spinnaker ratings. The ratings are not calibrated to accurately compare a spinnaker and non-spinnaker yacht.

SENIOR ONE-DESIGN CLASSES

NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*
- 1.2 Sections A, B and D of Appendix T will apply as changed:
 - (i) T1 is changed in accordance with YRA of LIS One –Design sailing instruction 17.
 - (ii) T2.2 is changed as follows:
 - (a) 30%, if taken before the protest time limit and before the beginning of arbitration or a protest hearing involving the incident.
 - (b) 40%, if taken before the beginning of a protest hearing involving the incident.

2 CLASSES

- 2.1 The regatta is open to the following one-design classes: Vipers, Etchells, J/70, IOD, Shields, S-Boat, Ideal 18, 505, and RS K6 or any other one design class that qualifies. To qualify as a class for this regatta, 3 valid entries must be received for that class prior to 1800, Wednesday, July 9.
- A class may elect to race on one weekend instead of the two that are scheduled. On days when a class elects not to race, boats in that class will not get a start, nor will they be scored, provided that the race committee has been previously informed of such class decision.

3 ENTRIES

- 3.1 Eligible boats may enter by registering online at: http://www.yachtscoring.com or www.larchmontyc.org, or on approved entry forms sent by mail or fax and received at the Larchmont Yacht Club front desk no later than 1200 Friday, July 11, 2014.
- 3.2 The entry fee is \$100.00 per boat. For classes electing to race one weekend the entry fee is \$85.00.
- 3.3 All entries not submitted online shall be mailed or faxed to the Larchmont Yacht Club,1 Woodbine Ave., Larchmont, NY 10538. Faxed entries will be accepted only with a valid signature for credit card authorization. Fax: 914-468-7751. All entries must be signed by the owner. Credit card authorizations must be legible and signed by the cardholder.

4 SAILING INSTRUCTIONS

The 2014 YRA LIS Mid-Sound One-Design Sailing Instructions will apply.
