1. RULES

- 1.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS).
- 1.2 The following prescriptions of U.S. Sailing, the national authority will apply: U.S. Sailing prescriptions for RRS 61.4, 67 and 76.1 will apply and will be posted on the Official Notice Board.
- 1.3 If there is a conflict between languages, the English text will take precedence.

2. ADVERTISING

Boats may be required to display advertising chosen and supplied by the organizing authority.

3. ELIGIBILITY AND ENTRY

- 3.1 Registration will open in 2020 with the intent to accommodate 100 competitors.
- 3.2 Eligibility will be determined as per the ISCA International Class Notice found here: https://www.sunfishclass.org/about/international-class-notice

4 ENTRY FEES

- 4.1 Championship entry fee: US\$500.00
- 4.2 Charter fee: US\$600.00
- 4.3 The combined entry and charter fees (US\$1,100.00) will be submitted as one payment. Payment can be made on YachtScoring or via wire transfer to the Class. Wire transfer instructions: Bank of America, N.A., 801 SE Maynard Road. Cary, NC 27511, USA. Account Name: International Sunfish Class Association, Account # 586024887862, International SWIFT # BOFAUS3N, Routing # 026009593. You must include an extra US\$16.00 for bank wire fees.











- 4.4 Registration fee includes as a minimum: hors d'oeuvres at the opening ceremony, dinner Tuesday, dinner Wednesday, dinner during awards ceremony and a tee shirt. Additional activities will be announced at check-in. Additional hospitality tickets can be purchased during via YachtScoring for \$100 including the three dinners.
- 4.5 Entry fee is in US Dollars and does not include bank transfer fee and or commissions. Any charge shall be reimbursed by competitors to complete their registrations.
- 4.6 Entry fee is non-refundable unless all 100 spots are filled by the date of the regatta. Refunds of entry fees are subject to a 10% administrative fee.
- 4.7 Eligible competitors may apply by completing the registration form available on-line at: https://yachtscoring.com/emenu.cfm?eid=11775. NSCAs and National Sailing Authorities can secure berths for their countries by completing a registration form and sending a payment.
- 4.8 Registrations are not considered official until all the payments have been received by the ISCA Office. Competitors can pay the registration fee by credit card, check, or wire transfer.
- 4.9 Reservation deadline for places within NSCA quotas is June 1, 2021 after which the Class Office will release unused reserved spots.
- 4.10 Entry and charter fees must be received by July 1, 2021 to secure official registration.

- 5.1. Three races are planned for each day.
- 5.2. One extra race per day may be sailed, provided that no more than one race becomes ahead of schedule.
- 5.3. On Friday, October 29, no warning signal will be made after 1400.
- 5.4. The reserve day will be observed unless either of the following conditions exist:
- 5.4.1. Fewer than eight (8) races have been completed.
- 5.4.2. The race committee, in their sole judgment, believes that sailing conditions expected on the final scheduled day of the regatta are unlikely to permit at least 2 races to be completed.

6. BOATS

- 6.1 All competitors will use charter boats provided by Sunfish Direct.
- 6.2 Addendum 1 lists all the equipment supplied and allowances for personal effects.

7 MEASUREMENT

- 7.1 The technical committee will inspect boats for compliance with class rules and any provisions in the NOR during scheduled hours prior to the regatta. At the discretion of the technical committee, race committee or the International Jury, boats may be re-measured at any time during the regatta and violations may be subject to protest. Measurement will take place only at the host club launching site.
- 7.2 Following measurement, any additions or changes to a competitor's boat and/or its equipment may only be done with the approval of the Race Committee. Competitors must advise the Race Committee of any such changes at their first reasonable opportunity.

8 SAILING INSTRUCTIONS

The Sailing Instructions will be available at check-in for the regatta.

9 VENUE

The regatta venue will be Sarasota Sailing Squadron, Sarasota FL. Racing will be in the waters of the Sarasota Bay.

10 THE COURSES

The courses will be windward – leeward.

11 PENALTY SYSTEM

- 11.1 Appendix P will apply.
- 11.2 If a judge witnesses an incident in which a boat protests another boat (hails "protest" at the first reasonable opportunity) as a result of the incident, and no boat takes a penalty, the judge may

- signal to impose a penalty by displaying a red flag with one long sound signal and hailing the sail number(s) of the boat(s) penalized. A boat so penalized by a judge shall take a penalty per RRS 44.2. If she fails to take it, she shall be disqualified without a hearing.
- 11.3 A boat involved in an incident where a judge signals under NOR 11.2 is not entitled to a hearing. This changes RRS 60, 61, 62, 63, 64.1, 65 and 66.
- 11.4 Decisions of the International Jury will be final as provided in RRS 70.5.

12 **SCORING**

- 12.1 Three (3) races are required to constitute a series.
- 12.2 A maximum of twelve (12) races will be sailed.
- 12.3 When fewer than six (6) races have been completed, a boat's series score will be the total of her race scores.
- 12.4 When six (6) to eleven (11) races have been completed, a boat's series score will be the total of her race scores excluding her worst race.
- 12.5 When twelve (12) have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

13 **SUPPORT BOATS**

- 13.1 The organizing authority will not provide support boats, Organizing Authority can be of assistance to arrange them.
- 13.2 Support boats include those carrying personnel that interact with competitors.
- 13.3 Support boats must register with the Organizing Authority and fly a yellow flag with a number provided by the Organizing Authority (a \$20 cash deposit will be required) at all times while on the water. Support boats shall carry a working VHF radio and monitor the race committee working channel.
- 13.4 Support boats shall stay outside the racing area from the time of the preparatory signal until all boats have finished or retired or the race committee signals a postponement, general recall or abandonment. The racing area is defined as no less than 100 meters from any boats that are racing and outside the laylines from the marks defining the course.
- 13.5 Support boats shall remain 100 meters below the starting line between the preparatory and starting signals. After the starting signal, they may only proceed to the windward mark up the left side of the course and must return to the leeward mark via the same side. At the finish line, they must remain 100 meters to windward of the extensions of the finish line.
- 13.6 No competitors shall be towed to the racecourse by support boats. All sailors must make it to the racecourse on their own.
- 13.7 If a support boat does not comply with applicable rules, restrictions and/or instructions, a discretionary penalty may be applied by the International Jury to some or all associated competitors and may include restrictions on the movement of their support boat.
- 13.8 Support boats may be required to act as safety boats upon instruction from a race official.

14 PRESS / PHOTOGRAPHY BOATS

- 14.1 Press or photography boats may be supplied or authorized by the organizing authority.
- 14.2 Press or photography boats shall be marked with a flag with a letter "P".
- 14.3 Press/photography boats shall stay outside the laylines to the marks defining the course while boats are racing and shall not maneuver so as to interfere with or influence boats racing.
- 14.4 Press/photography boats shall obey instructions related to boat positioning or operations from on-the-water race officials.

15 **BERTHING**

Boats shall be kept at the regatta site and in (numbered) spots assigned by the organizing authority.

16 **PRIZES**

Prizes will be given as follows:

- a) Top ten finishers
- b) Highest placed Female finisher (if the top finisher is male) or the highest placed Male finisher (if the top finisher is Female)
- c) Highest placed Youth
- d) Highest placed Apprentice Master (40+)
- e) Highest placed Master (50+)
- f) Highest placed Grand Master (60+)
- g) Each race winner (max 12)
- h) Youngest Participant
- i) Oldest Participant
- j) The Marco Polo Prize (for participant from the farthest away)
- k) Dave Thompson Trophy for Sportsmanship (voting ballot provided in registration packets and turned in to SSS Office by 1500 Friday, Oct. 29.)

17 **DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

18 **INSURANCE**

The organizing authority recommends that each competitor shall be insured with valid third-party liability insurance.

Addendum 1

(Equipment Supplied and Allowances for Personal Effects)

Sunfish Direct will provide new boats to all competitors with the equipment listed below.

- o Hull
- Spars and mast
- o 2021 ISCA Worlds Sail
- o Blades dagger board and rudder with tiller & tiller extension
- Gooseneck with quick release lever
- Outhaul cleat on the lower spar
- Cunningham cleat on the lower spar
- Hiking strap
- Cockpit self-bailer (must be used with O-rings for mounting)
- Beach dolly
- o Ratchet-block & Line package: halyard, mainsheet, outhaul, cunningham, sail ties, shock-cord

Competitors may provide the following personal effects.

- Mainsheet
- Bronze Gooseneck (in the event stainless steel goosenecks are provided)
- Gooseneck quick adjuster
- Line for the outhaul
- o Line for the Cunningham or line for an uphaul
- Ratchet block for the mainsheet with stand-up spring
- Line for the halvard
- Tie lines for the sail or sail clips
- Corner tie lines
- Shock cord with end fittings for dagger board
- Jens line and reefing line
- Second halyard
- Removable mast cleat for halyard (no holes to be drilled) and padding/hardware to attach
- Tiller extension with universal fitting compatible with receiver fitting provided on tiller
- o Line, shock cord or other Class approved materials for securing or raising the hiking strap
- Flexible mainsheet hanger(s)
- Wind indicators and/or telltales
- Thimbles in line purchases where allowed
- Compass and/or stopwatch
- o Paper or other sheet material temporarily taped to deck and pen or pencil for recording notes
- o Tape or Velcro (but not allowed in centerboard trunk or mast step)
- o Line, tape and/or plastic tubing to make dagger board, outhaul & Cunningham handles
- Hand bailer with lanyard, sponge and soap to wash hull
- McLube or comparable dry spray lubricant to be used only on spars, sail ties and sail controls
- * All rigging installations are subject to compliance with current Class rules, event Charter Agreement, and provisions in the NOR.

Other Actions: Use of any other equipment or materials not mentioned in this addendum are prohibited. This includes but is not limited to prohibit the use of anything in the centerboard trunk or mast step, application of sealants or anything other than soap on the hull or blades.
