# NOTICE OF RACE

with Amendment No. 1

To accommodate this event under the current circumstances multiple changes have been made. All are detailed immediately below.

Revise the race entry fees, days of racing for J/70 fleet, and last day to register. NoR 3.1, 3.2, and 3.3 are replaced with the following.

- 3.1 The J/70 entry fee for two (2) days of racing is:
  - \$100 for paid entries received by 2000 hours on Friday, 23 October 2020.
  - \$125 for paid entries received after 2000 hours on Friday, 23 October 2020, but before 1900 hours on Thursday, 29 October 2020.
- 3.2 The J/80 entry fee for one (1) day of racing is:
  - \$50 for paid entries received by 2000 hours on Friday, 23 October 2020.
  - \$75 for paid entries received after 2000 hours on Friday, 23 October 2020, but before 1900 hours on Thursday, 29 October 2020.
- 3.3 The Viper 640 entry fee for two (2) days of racing is:
  - \$100 for paid entries received by 2000 hours on Friday, 23 October 2020.
  - \$125 for paid entries received after 2000 hours on Friday, 23 October 2020, but before 1900 hours on Thursday, 29 October 2020.

- 12.1 For the J/70 class overall awards will be presented at EYC on Sunday, 01 November 2020, after the conclusion of racing, social distancing will be observed.
  - 1<sup>st</sup> Place for three (3) or more entries;
  - 2<sup>nd</sup> Place for six (6) or more entries;
  - 3<sup>rd</sup> Place for seven (7) or more entries.: and.
  - 4<sup>th</sup> Place for fifteen (15) or more entries.
- 12.3 For the J/80 class overall awards will be presented at EYC on Saturday, 31 October 2020, after the conclusion of racing, social distancing will be observed.
  - 1<sup>st</sup> Place for three (3) or more entries;
  - 2<sup>nd</sup> Place for six (6) or more entries;
  - 3<sup>rd</sup> Place for seven (7) or more entries; and,
  - 4<sup>th</sup> Place for fifteen (15) or more entries.
- 12.4 For the Viper 640 class, overall awards will be presented at EYC on Sunday, 1 November 2020, after the conclusion of racing, social distancing will be observed.
  - 1st Place for three (3) or more entries;
  - 2<sup>nd</sup> Place for six (6) or more entries;
  - 3<sup>rd</sup> Place for seven (7) or more entries; and,
  - 4<sup>th</sup> Place for fifteen (15) or more entries.
