1 RULES

- 1.1 All races organized by the Lake Erie Challenge (LEC) will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS), this *Notice of Race* (NOR), and the *Sailing Instructions* (SI).
- 1.2 Prescriptions of 2017-2020 US Sailing and Performance Handicap Racing Federation Lake Erie (PHRF-LE) except as any of these are modified by the NOR, and by the SI (and any amendments thereto) shall apply to all boats.
- 1.3 RRS 63.7 shall be replaced by: "If there is a conflict between a rule in the Notice of Race and a rule in the Sailing Instructions, the Sailing Instructions shall apply"

2 ADVERTISING

- 2.1 Competitor advertising will comply with World Sailing Regulation 20.
- 2.2 Boats may be required to display advertising chosen and supplied by the organizing authority.

3 ELIGIBILITY & ENTRY

- 3.1 All races are open to all boats. A boat is considered registered after both the online registration has been completed and the entry fee has been received by the organizing authority.
