8.2 LONG COURSE DIAGRAM







8.5 AREAS THAT ARE OBSTRUCTIONS: The area around the pumping stations (cribs) and the marks placed around them by the Coast Guard are hereby designated as an obstruction. Boats shall treat them as such and not sail between the marks and their associated crib. The area south of 31st street harbor annotated as the Morgan shoal shall be considered an obstruction; boats must remain either East or North of the red nun-buoy #2 indicating the edge of the shoal.

10. FINISH (The following modifies Sailing Instruction #10)

10.1 SAIL NUMBERS must be displayed on the starboard side of the boat at the finish. This display may be on the mainsail and/or a sail number board. There is no requirement as to the material used in the construction of the sail number board, however the color of the numbers will be contrasting to the board and the numbers should be at least 10 inches in height.
