## Notice of Race

North Star Sail Club, Harrison Township, MI, USA, is the organizing authority and will provide race management.

### 1. Rules

- 1.1. This race will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS) and as modified by the *Anchor Bay Yacht Racing Association 2020 Racing Handbook* (ABYRA Handbook), this notice of race, and the sailing instructions for this race.
- 1.2. The ABYRA Handbook will be posted on YachtScoring.com (also available through the NSSC website NorthStarSail.org/Racing) no later than one week prior to the event.

### 2. Eligibility and Entry

- 2.1. This race is open to sail yachts owned or chartered by individual members of clubs or associations that are members in good standing of ABYRA, DRYA, or US Sailing, and who have paid their race fees.
- 2.2. This race is open to JAM, asymmetrical, and spinnaker classes. Class splits will be posted at NSSC clubhouse no later than 2 hours before the race. Five boats are required for a class.
- 2.3. Registration shall be submitted according to registration instructions on YachtScoring.com (also available through the NSSC website NorthStarSail.org/Racing). Completed entry forms shall be received by 1200 on the day prior to the event.
- 2.4. Late entries will be accepted and will be subject to a \$5.00 late fee.

### 3. Fees

- 3.1. The entry fee for this race is \$35.00.

### 4. Schedule

- 4.1. The race is scheduled for August 22, 2020.
- 4.2. The warning signal for the first start is scheduled for 1100.

### 5. Measurement

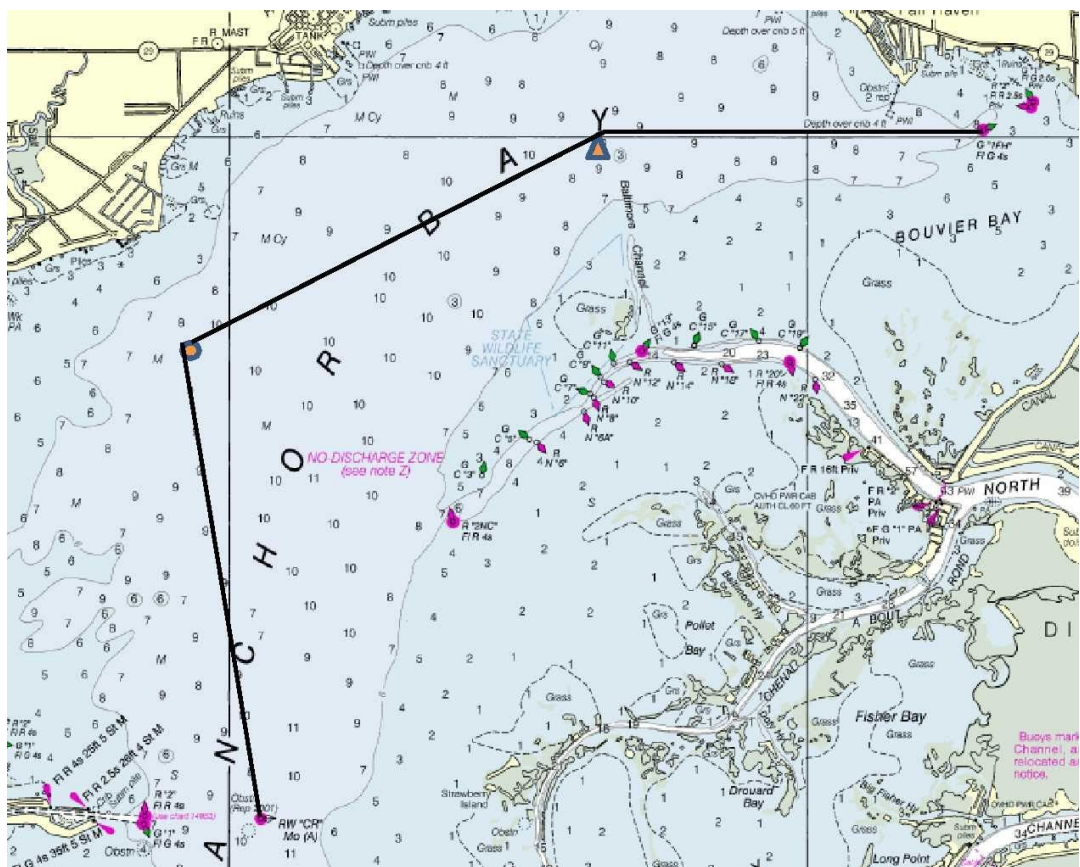
- 5.1. If a boat does not have a current DRYA rating certificate, the RC will assign a temporary rating as described in the ABYRA Handbook.

### 6. Sailing Instructions

- 6.1. Sailing instructions for this race will be posted on YachtScoring.com no later than one week prior to the event.

### 7. Venue

- 7.1. The venue will be Anchor Bay, Lake St. Clair. The chart shows the approximate location of the rounding marks.



**8. Courses**

8.1. The course will start at CR1, east of the Clinton River channel, leave ABYRA C racing mark to starboard, leave an inflatable orange mark approx. 42°39.91' N 082°41.66' W to starboard, then round the Fair Haven Buoy 1FH to port, then leave the inflatable orange buoy to port, leave ABYRA C racing mark to port and finish at CR1.

**9. Scoring**

9.1. The race will be scored using time-on-time over PHRF for classes and division overall.

**10. Awards**

10.1. Awards will be presented following the race.

**11. Disclaimer of Liability**

11.1. Competitors participate in the race entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the race.

**12. Insurance**

12.1. Each participating boat shall be insured with valid third-party liability insurance.
