



IDA LEWIS DISTANCE RACE SAILING INSTRUCTIONS

Including Amendment #1 ,#2, #3 and #4

AUGUST 20-21, 2021

Organizing Authority: Ida Lewis Yacht Club

*We anticipate that there may be updates and/or amendments to the Notice of Race and Sailing Instructions based on information provided or regulations mandated by the State of Rhode Island regarding Covid-19. The health, safety and welfare of our volunteers and participants is of utmost importance and ILYC will adhere to these regulations. Updates and Amendments will be posted on the Official Notice Board(found on the Yacht Scoring event site), www.ILYC.org/distancerace, and emailed to all registered entries.

1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 For all boats sailing courses 1, 2,3 or 4, the US Safety Equipment Requirements of US Sailing for **US Coastal**. A boat may not be protested for failing to comply with these Requirements except by the Race or Protest Committees.
- 1.3 For all boats sailing courses 5, 6, 7 & 8, the US Safety Equipment Requirements of US Sailing for **Nearshore**. A boat may not be protested for failing to comply with these Requirements except by the Race or Protest Committees.
- 1.4 The current ORC rules.
 - 1.4.1 ORC Rule 200.1 is changed as follows:
 - i. One additional crew under the age of 16 is permitted and shall not count against the crew or weight limit.
 - ii. Weighing in is not required. However, the skipper of a boat that is later protested for exceeding the maximum crew weights cited on the boat's certificate shall make all crew weights available prior to the protest hearing and will be required to certify to the accuracy of the data.
- 1.5 For PHRF divisions - the current PHRF Regulations of the Narragansett Bay PHRF Association.
- 1.6 Rules 28, 29.1, 41, 60.1, 63.1, 63.2, 64.1, A5 and Race Signals are changed.

2 NOTICES TO COMPETITORS

Notices to competitors will be posted on the Official Notice Board on the Yacht Scoring Event Web Site.

3 CHANGES TO THE SAILING INSTRUCTIONS

Any changes to the Sailing Instructions for:

Courses 1-4 will be posted before 0800 hours on Friday, August 20th Courses 5-8 will be posted before 0800 hours on Saturday August 21

4 SIGNALS MADE ASHORE

- 4.1 Signals made ashore will be flown from the yardarm of the flagpole at Ida Lewis Yacht Club.
- 4.2 When flag AP is displayed ashore, the warning signal will be made not less than one (1) hour after flag “AP” is lowered. This changes Race Signals.
- 4.3 The Race Committee will make announcements concerning postponements, courses, premature starters, etc., on VHF Channel 79A. Failure of of competitors to receive or hear such announcements will not be grounds for redress.

- 5.3 While racing, each boat shall display the numeral pennant for her respective class from her backstay no less than six (6) feet above the deck.

6 CHECK IN AND RETIREMENT

- 6.1 Prior to the first warning signal, all boats shall check in with the Race Committee by hailing the Race Committee on VHF CHANNEL 69 with their sail numbers and having the Race Committee affirmatively respond.
- 6.2 Boats retiring shall inform the Race Committee by phoning (401) **341-8195** as soon as possible.

8 THE START

- 8.1 Friday, August 20
 - ORC Warning Signal 1100 hours
 - Double-Handed Warning Signal 1110 hours
 - PHRF Aloha Warning Signal 1120 hours
 - PHRF Coronet Warning Signal 1130 hours
 - Cruising Spinnaker Warning Signal 1140 hours
- 8.2 Saturday, August 21
 - PHRF Aloha Warning Signal 1000 hours**
 - PHRF Coronet Warning Signal 1020 hours**

- 8.3 Races will be started in accordance with rule 26.
- 8.4 The starting line will be between a staff flying an orange flag on the Race Committee Signal Boat anchored south of Rose Island in the East Passage of Narragansett Bay and the nearby race mark.
- 8.5 The starting race mark will be an extra large Orange Dumpty.
- 8.6 Boats shall keep clear of the starting area unless starting.
- 8.7 Any boat not starting within **10** minutes of the last starting signal of the day shall be scored DNS without a hearing. This changes rule A5.
- 8.8 The Race Committee shall hail boats starting prematurely on VHF Ch 79A; however failure of a boat to receive or hear this transmission is not grounds for redress. This changes rules 29.1 and 41.

9 THE FINISH

- 9.1 The finish shall be a line between G“3” Fl G 2.5 sec Bell off Goat Island and a staff flying an Orange flag (which will be illuminated at night) at the north end of the deck at Ida Lewis Yacht Club.
- 9.2 A Mark of the Course, Newport Mooring Field Limit Mark (yellow inflatable buoy) will be placed at approximately 41 ° 28.81 'N, 071 ° 19.61 'W (in the general vicinity of the finish line) **This mark, which shall be left to starboard, is a mark of the course, but**

NOT PART OF THE FINISH LINE . It is intended to provide a rough approximation of the angle of the finish line. **If, as a result of a valid protest hearing, the protest committee determines that a boat failed to honor this mark and sail the course correctly, the minimum penalty the protest committee shall assess is one hour added to the boat's corrected time. This changes rule 64.1.**

- 9.3 All boats in the classes assigned to sail courses 1, 2, 3, 4, and 6, when they are abeam of Castle Hill Light approaching the finish, shall call the Race Committee on VHF Ch 79A or via telephone (401) **341-8195** and report their boat name, sail number and time. If reporting by telephone, information may be left on the race answering machine.
- 9.4 All boats in all classes assigned to sail course 5, when they are about to pass under the Pell Bridge approaching the finish, shall call the Race Committee on VHF Ch 79A or via telephone (401) **341-8195** and report their boat name, sail number and time. If reporting by telephone, information may be left on the race answering machine.
- 9.5 At night, boats shall illuminate their sail numbers when approaching the finish line.
- 9.6 Boats shall take their own finish time and report this to Race Committee at Ida Lewis Yacht Club within **ONE** (1) hour after finishing.
- 9.7 Boats shall complete and sign a declaration that they have sailed the race in accordance with the Rules; and shall deliver it to the Race Committee on the RC mark boat after finishing or to the Race Committee at the Finish Line Desk on the deck on the north side of the Ida Lewis Yacht Club within ONE (1) hour after finishing.

10 PENALTY SYSTEM

RRS 44.3, Scoring Penalty, shall apply.

11 TIME LIMIT

- 11.1 The time limit for all boats sailing courses 5, 6, 7 and 8 is 1800 hours on Saturday, August 21, 2020.
- 11.2 The time limit for all boats sailing courses 1, 2, 3 and 4 is 1800 hours on Saturday, August 21, 2020

12 RENDERING ASSISTANCE

Attention is drawn to the responsibility imposed by good seamanship and RRS1.1

13 PROTESTS

- 13.1 Boats intending to file a protest or a request for redress shall inform the Race Committee immediately after finishing by radioing the Race Committee on VHF Ch 79A or calling the race office at (401) **341-8195** until acknowledged.
- 13.2 Protests must be submitted in writing to the Race Committee at Ida Lewis Yacht Club within one (1) hour of finishing. Protest forms will be available at the Race Committee Finish Line Staff located on the deck on the north side of the Ida Lewis Yacht Club.
- 13.3 The Protest Committee anticipates that it will begin hearing protests at 1300 on Saturday, August 21, 2020.
- 13.4 The Jury may apply a penalty other than disqualification for breaking a Rule other than one of Part 2 of the Racing Rules.

14 SCORING

- 14.1 **ORC:** Time allowances for ORC boats will be calculated using the boat's single number All Purpose Time-on-Time (TOT) rating.
- 14.2 PHRF: Time allowances for PHRF boats will be calculated using Time-on-Time (TOT) with the handicaps as provided by PHRF-Narragansett Bay.

15 GOVERNMENT BUOYS

Government buoys, when not specified as part of the course, have no required side except for safe navigation.

16 ADVERTISING

- 16.1 Advertising shall be in accordance with ISAF regulation 20.
- 16.2 Competitors may be required to display sponsor flags or graphics on the side of their hulls; these graphics, if any, will be supplied by the OA.
- 16.3 Advertising for tobacco products are prohibited.
- 16.4 Advertising that conflicts with any race sponsor is prohibited unless permission is requested and authorized by the OA in writing.

17 PRIZES

- 17.1 Prizes will be awarded on **Saturday**, August 21 at 1950 hours at Ida Lewis Yacht Club
- 17.2 The following prizes will be awarded:
- A. The Russell L. Hoyt Memorial Trophy for the IRC Division Best Elapsed Time.
 - B. The Lois J. Muessel Memorial Trophy for the PHRF Division Best Elapsed Time for Race Courses 1-4.
 - C. The Commodore's Trophy for the IRC Division, Corrected First Place.
 - D. The Lime Rock Trophy for the PHRF Division, Corrected First Place. for Race Courses 1-4.
 - E. Double-Handed Division, Corrected First Place.
 - F. The Arent H. Kits van Heyningen Trophy for the Youth Challenge, Corrected FirstPlace for Race Courses 1-4.
 - G. William E. Tuthill Trophy for the Collegiate Challenge, Corrected First for Race Courses 1-4.
 - H. Cruising Spinnaker Division Trophy, Corrected First Place for Race Courses 1-4 and 5-8
 - J. PHRF Category A (PHRF Rating 54 and lower) – Corrected First Place for Race Courses 1-4 and 5-8
 - K. PHRF Category B (PHRF Rating 55 and higher) – Corrected First Place for Race Courses 1-4 and 5-8

Additional prizes may be awarded at the sole discretion of the organizing authority and may be based on criteria other than the regatta results.

18 NOTES

- 18.1 In the event that life-saving equipment is lost overboard, it should be recovered. If recovery is impossible, any equipment that floats shall be reported immediately to the Race Committee and the nearest U.S. Coast Guard station on VHF Ch 16.

- 18.2 Competitors are reminded of their responsibility to comply with the U.S. Coast Guard Pollution Regulations.
- 18.3 Narragansett Bay is a restricted channel and sailing vessels do not have right-of-way over a vessel under power which may be restricted in her ability to maneuver.
- 18.4 Skippers are reminded that there is shallow water on the northwest shore of Fort Adams.
- 18.5 In an emergency, if there is no one on duty at (401) **341-8195**, competitors are requested to call (401) 862-3840.
- 18.6 Competitors not in their starting sequence who wish to contact the Race Committee shall do so on VHF CHANNEL 69.
- 19 SPECIAL LIMITATIONS and REQUIREMENTS**
- 19.1 All yachts sailing course 1-4 shall carry, mount, and keep turned on while racing a Yellow Brick transponder provided by the Organizing Authority. Transponders shall be mounted on a stanchion in a location exposed to the sky and aft of the steering station. The transponder must be returned to the Race Committee after finishing. A participant not returning the transponder by the end of the race time limit or two hours after finishing, whichever is later may be scored DNF without a hearing and will be charge for the cost of this transponder. This changes RRS 63.1.
- 19.2 The US Sailing prescription to rule 63.2 is deleted.
- 19.3 Protests alleging infringement of SI paragraphs 9, 18, and 19 shall only be initiated by the Ida Lewis Long Distance Race Organizing Authority. This changes RRS 60.1
