## NOTICE OF RACE WITH AMENDMENTS #1 & #2 POSTED 8.16.21

**Amendment #1:** Addition of 13. **Image & Video Rights** & Subsequent Renumbering  
**Amendment #2:** Amendment of 3. **Schedule**, changing Optional Skippers Meeting to 1030 Saturday, earliest first warnings to 1200 Saturday & 1030 Sunday, and no warning signals past 1330 Sunday

### 1. Rules

1.1 – The regatta will be governed by the rules as defined in The Racing Rules of Sailing.

1.2 – The US Sailing Prescription to Rule 63.4 will not apply. The USSailing Prescriptions are available at [www.ussailing.org/](http://www.ussailing.org/).

1.3 The Racing Rules will be changed as follows. The changes will appear in full in the Sailing Instructions (SIs). The SIs may also change other racing rules.

- a) Race Signal AP – when displayed ashore, ‘one minute’ is replaced by ‘sixty minutes’.
- b) 44.1– the ‘Two-Turns Penalty’ is replaced by the ‘One-Turn Penalty’.
- c) App A2 - A boat’s series score will be the total of her race scores (no throwouts).
- d) App A4.2 – A boat that does not finish (DNF) a race or retires after finishing (RAF) shall be scored one more point than the last boat to finish in that race.

### 2. Eligibility, Entry & Fees

2.1 The regatta is open to all boats that conform to the Rules of the International Melges 24 Class.

2.2 Eligible boats may enter at [www.yachtscoring.com](http://www.yachtscoring.com) and paying the required fees. Entry forms will also be available at GTYC and boats may enter during registration.

2.3 The required fee for the regatta is \$250.00, payable via Yachtscoring.com by midnight Wednesday, August 17th. Entries made from August 18th to 0930 August 20 will be \$275.00. The entry fee includes 4 dinners on Saturday Night. Additional dinners will be available during registration.

**4. Sailing Instructions** — will be available at registration and online at Yachtscoring.com

**5. Venue** – will be West Grand Traverse Bay within a 1.5 mile radius of Red 8.

**6. Courses** – will be 4 Leg Windward/Leewards.

**7. Penalty System** – RRS 44.1 is changed so that the ‘Two-Turns Penalty’ is replaced by the ‘One-Turn Penalty’.

**8. Scoring** –

8.1 Nine (9) races are scheduled and one (1) race is required to be completed to constitute a series.

8.2 A boat’s series score will be the total of her race scores (no throwouts). This changes RRS App A2.

8.3 A boat that does not finish (DNF) a race or retires after finishing (RAF) shall be scored one more point than the last boat to finish in that race. This changes RRS App A4.2

**9. Boat Launching** – Boats may be dry sailed from ramps at either GTYC or Elmwood Township Marina.

**10. Radio Communication** – Communication for the racing will utilize VHF radios with the working channel to be determined. Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

**11. Prizes** – will be awarded to crews placing 1st through 5th in the regatta. Additional prizes may be awarded.

**12. Disclaimer of Liability** – Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained as a result of participation in this event. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor’s participation in this event to the fullest extent permitted by law.

**13. Image & Video Rights** — Competitors give absolute right and permission for video footage or photographs of themselves or their boat to be published in any media for press, editorial or advertising purposes.

**14. Insurance** – Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000 (USD) per incident or the equivalent.
