Notice of Race (NOR)

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1 RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*
- 1.2 If there is a conflict between this Notice of Race and the Sailing Instructions, the Sailing Instructions shall take precedence

SAILING INSTRUCTIONS

2.1 Sailing instructions for the specific race date will be posted at www.yachtscoring.com ("YS") no later than 1800 hrs. on the Thursday preceding that specific race date. They may be posted earlier as preliminary.

3 COMMUNICATIONS

- 3.1 The Official Notice Board will be located online at www.Yachtscoring.com. Enter "Dunedin" in the search and select the Dunedin Boat Club Bay Summer Series.
- 3.2 The Race Committee may use RR 90.2[C] to make changes to NOR and/or SI on the water.

4 ELIGIBILITY

- 4.1 The races are open to all classes of sailboats. WF PHRF current rated Class and one design class.
- 4.2 There must be a minimum of 3 keel boats, 3 sunfish or 3 420's for there to be a race for that respective class.
- 4.3 Eligible boats must register in advance through online <u>www.yachtscoring.com</u>. Deadline for entry is 1700 hrs. on the Thursday evening preceding the date of race. There will be no same day registrations accepted.
- 4.4 The boat must be owned by a member in good standing of a recognized yacht club, sailing club or like organization.
- 4.5 No boat's entry will be final without a completed and signed online YS waiver from each participating crew member. If there is a crew member substitution, that crew member must complete and sign an online YS waiver. The skipper shall inform the Organizing Authority or PRO of same prior to the first warning that day. Skippers are encouraged to have their current and future crew members register themselves at YS for efficient use of the site.
- 4.6 No boat will be scored without completing all entry requirements.

5 ENTRY FEE

5.1 Entry fee is a one-time \$20 fee whether you race one race date or all four race dates. Entry fee includes sales tax and bank fees. Fees can be paid with credit card at registration on YS.

6 SCHEDULE

6.1 May 7th, 2021 / May 21, 2021 / June 4th, 2021 / June 18th 2021

7 SCORING

- 7.1 All scoring will be managed on YS
- 7.2 Participation in 3 of 4 race days is required in order to qualify for an award. If a competitor participates in all 4 days, her wors days score will be thrown out.

8 SIGNALS MADE ASHORE

- 8.1 Race Committee will run the races from the DBC floating dock located on the west side of the Clubhouse on St. Joseph's Sound. This location will be called SIGNAL.
- 8.2 Check-in is required by competitors prior to 1840 hrs. Competitors can check-in via VHF radio or by hailing Race Committee as they pass the floating dock where they will be staged. Those not acknowledged by Race Committee will not be scored.

9 VENUE and START/FINISH

- 9.1 The racing area will be St. Joseph's Sound directly in front of the Dunedin Boat Clubhouse floating dock.
- 9.3 Marks are government marks as described in the Sailing Instructions (SI).

10 PROTEST

10.1 Protests should be resolved on the water. In the event of a bodily injury or material damage, a formal protest should be filed. The Race Committee must be notified by the end of the race. The parties involved will be notified as to when a hearing will take place. Protest forms are located on YS.

11 RISK STATEMENT

11.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone. By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.

Competitor/Skipper is liable for the safety and behavior of their crew. Competitors will abide by all the rules, regulations and documents that will govern this Regatta including any safety related measures required by any State emergency order(s) issued as a result of any health orders by the Federal, State or Local Government. Competitors voluntarily assume the risks associated with communicable diseases including but not limited to COVID-19. 12 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance. Competitor will be required in YS to indicate the name of their Insurance Carrier and their Insurance Policy Number only.

13 PRIZES

13.1 Prizes for the SERIES overall finishes will be awarded for 1st, 2nd and 3rd place.
