1. RULES:

- 1.1 This regatta will be governed by the current version of *The Racing Rules of Sailing*.
- 1.2 The following prescription of US Sailing will not apply: RRS 63.2.
- 1.3 Appendix V2 will be in effect.

9. PENALTY SYSTEM:

8.1 Rule V2 of Appendix V will be elaborated in the sailing instructions. including where to go for necessary forms to be completed and to whom it should be submitted.

8.2 Rule 44.1 is changed so that the Two-Turn Penalty is replaced by the One-Turn Penalty (including one tack and one gybe).

10. SCORING:

- 10.1 An unlimited number of races are scheduled on all courses.
- 10.2 One race completed will constitute a regatta.
- 10.3 The regatta will be scored with the low point system as described in RRS, Appendix A as amended to read that if more than 5 races are scored, each boat will exclude the worst score.

10. Support Boats:

All coach and parent boats shall register with the Race Committee. Each coach and parent boat shall have a working VHF radio and abide by the directions and instructions of the Race Committee.

11. Prizes:

Trophies will be awarded to the top 3 finishers of the O'pen class and Optimist class. There will be an additional trophy for the top White, Blue, and Red fleet sailor.

12. Risk Statement

RRS 3 states: 'The responsibility for the boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia, or other causes. Daniel Island Yacht Club will not accept any liability for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.
