Notice to Competitors #2

**Amendment #2 to the Notice of Race
and
Amendment #1 to the Sailing Instructions**

For the avoidance of doubt, NOR Amendment #1 stands as Notice to Competitors #1.

Add NOR 1.3:

- 1.3 NEMA Multihulls will be sailing as an exhibition fleet only, and will have separate Sailing Instructions and scoring procedures, which will be managed and communicated by the event's NEMA Class Captain. For the NEMA Multihulls, this NOR and the main (beach catamaran) SIs are for reference only.

In NOR 2.1, replace "22 feet" with "23 feet."

In NOR 2.4, add: "Based upon registration, the Open Class may be split into spinnaker and non-spinnaker classes."

In NOR 4.1, add clarification that on-site Check In on Saturday morning is mandatory.

In NOR 6.2, replace "southwest of" with "south of."

Delete NOR 11 and replace with:

11 RADIO COMMUNICATION

- 11.1 For safety, all boats are strongly urged to sail with at least one submersible VHF radio. Best practice is one VHF radio per person, attached to each person.
- 11.2 Except in an emergency (or if rendering aid), boats shall not make radio transmissions while racing.
- 11.3 Boats may receive information via VHF radio at any time, and are encouraged to monitor the RC for information throughout the regatta.
- 11.4 Class rules restricting the use of radios shall not be grounds for protests. *This changes RRS 60.1(a).*
- 11.5 Except in an emergency, boats shall neither transmit nor receive information via mobile telephone at any time while racing.

In NOR 13, replace “RRS 4” with “RRS 3.”

In SI 5, add mandatory on-site Check In on Saturday morning.

In SI 7.1, replace “southwest of” with “south of.”

In SI 11.1, replace “005°” with “010°.”

Change SI 14.2 as follows:

- 14.2 FINISHING ON THE WATER: Boats may be finished on the course at the discretion of the RC. The RC determines the method and order of finishing, **and may assign finish times to Open Class boats.** *This changes RRS 35 and A4, **and amends SI 12.1.***

Add new SI 15.2 as follows, and renumber the remainder of the section:

- 15.2 Boats intending to file a protest are requested to report to the RC upon finishing.

In SI 15.4 (formerly 15.3), change “RRS 63.1” with “RRS 62.2.”

Add new SI 15.8 as follows, and renumber the remainder of the section:

15.8 A decision made by the RC under SI 17.4 shall not be grounds for a request for redress by a boat. *This changes RRS 62.1(a).*

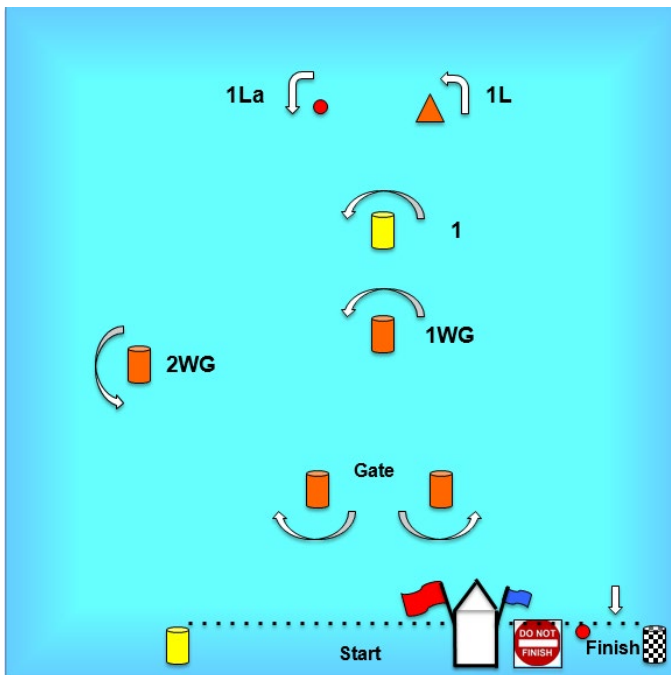
Clarify SI 17.4 to state “This changes RRS 63.1 and A5.”

In SI 21.1, replace “RRS 4” with “RRS 3.”

In Appendix A, change the Getaway & Wave course description as follows:

Course G: S-1WG-2WG-Gate-1WG-F (downwind) [aka Triangle - Sausage]

In Appendix A, delete the course diagram and replace with the following:
