## **1. RULES**

- 1.1 This Regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS). To the extent permitted by Part 7 of the RRS, specific provisions of the RRS may be modified, altered, or made inoperative by the Notice of Race (NOR) or the Sailing Instructions (SI).
- 1.2 The International Optimist Dinghy Association Class Rules, the Rules of the Laser Class Association and the Rules of the Sunfish Class International Racing Association, except as any of these are altered by this Notice of Race and/or by the Sailing Instructions.
- 1.3 If there is a conflict between languages the English text will take precedence.

## **2. ELIGIBILITY AND ENTRY**

- 2.1 Due to the Puerto Rico Government Executive Orders, the PYFC internal regulations and the safety of all visitors, members, and the organizing authority a COVID-19 Vaccination Record Card with valid government ID or a Negative COVID-19 Test with less than 72 hours must be presented before entering the PYFC facilities.
- 2.2 There will be Twelve (12) divisions for entry.
  - Optimist Advanced, Green & Super Green
  - Laser 4.7 & Radial
  - Sunfish
  - 420
  - O'Day Mariner & Rhodes
  - Wind Surfer
  - Wind Foil
  - Playero
- 2.3 Eligible boats may enter by completing registration in [www.yachtscoring.com](http://www.yachtscoring.com) and with the regatta committee at the Regatta Headquarters.
- 2.4 The Optimists competitors must be between 7 and 15 of age.
- 2.5 The Race Committee reserves the right to divide the Optimist class into as many as four fleets, designated as Red, White, Blue, and Green.
- 2.6 A minimum of three (3) boats for each class is required to constitute a class.
- 2.7 The Race Committee reserves the right to waive eligibility to vessels in order to allow fair and maximum participation.
- 2.8 If you are not a current member of a class, membership to the appropriate association will be available at registration for a nominal fee.



### 3. REGISTRATION

- 3.1 Registration and payment in full shall be done using [www.yachtscore.com](http://www.yachtscore.com) no later than Friday, November 12, 2020.

4.7 An **11.5%** IVU tax is going to be charged at registration, as per PR government.

4.8 For a registration to be considered as complete it must be paid in full at the moment of Registration and within the deadlines expressed in 4.1, 4.2, 4.3, 4.4, 4.5, 4.7, 4.8 and 4.9. Failure to comply with the payment within the deadlines a registration will be considered incomplete and charged the rate at the payment date.



## **5 SCHEDULE**

### **5.1 Skippers check in and Late Registration**

5.1.1 At Regatta Headquarters on Saturday Nov. 13, 2021, from 0800 hours to 1000 hours. Competitors shall register at the Registration Desk in the PYFC Office.

5.1.2 All competitors must complete registration before the Skipper's meeting.

### **5.2 Skippers Meeting**

5.2.1 The Skippers Meeting will be held at the beach area at 0930 hours on Saturday Nov. 13, 2021

### **5.3 Races**

5.3.1 Races will be back-to-back.

5.3.2 The First warning signal is scheduled for 1200hrs on Saturday Nov 13 and 1100 hours Sunday Nov 14, 2021.

5.3.3 No warning signal will be hoisted after 1600 hours on Saturday. No warning signal will be hoisted after 1400 hours on Sunday.

## **6. SAILING INSTRUCTIONS**

6.1 The sailing instructions will be available in [www.yachtscoring.com](http://www.yachtscoring.com)

6.2 This regatta is working towards being a Green Regatta. Competitors can print their own SI or use the online SI.

6.3 The Race Committee will only supply the courses in print.

6.4 A copy of the Sailing Instructions will be posted in the Official Notice Board in the Marlin Room.

## **7. RACING AREA**

7.1 The Race will take place in the navigational waters adjacent to Ponce Bay.

## **8. SCORING**

8.1 Scoring will be done using Appendix A, A4 Low Scoring System.

8.2 A minimum of one (1) race will constitute a regatta.

8.3 When five (5) or fewer races have been completed, a boat's series score will be the total of her race scores.

8.4 When from six (6) to ten (10) races have been completed a boats series score will be the total of her series scores excluding her (1) worst score.

8.5 When from eleven (11) to fifteen (15) races have been completed a boats series score will be the total of her series scores excluding her two (2) worst scores.

## **9. SHORE FACILITIES**

9.1 Boats will be accommodated at the Golf and Beach area at the Ponce Yacht and Fishing Club.
