32nd Annual Fall Regatta
Leukemia Cup Regatta

and J/105 New England Championship

September 24, 25 & October 1, 2, 2022

Organizing Authority: American Yacht Club, Rye, NY

1. RULES

- 1.1. The regatta will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2. US Sailing Special Equipment Requirement (USSER) for **Nearshore** races shall apply.
- 1.3. The IMS and ORC Rating Systems Rules apply to **ORC classes**.
- 1.4. The regatta is designated as **Level 2 under J/105** class rule 3.4, and **Level A under J/105** class rule 3.6. The **J/105 Fleet Six junior exemption** (Article 9.8) shall apply.
- 1.5. For the **Doublehanded** class only, RRS 52 is changed by adding: However, the rudder may be adjusted and operated by an autopilot using power that is not provided by the crew.
- 1.6. Boats shall keep clear of commercial shipping as required by the IRPCAS or other government right-of-way rules. The penalty for breaking this rule may be disqualification, which also may be non-excludable, from one or more races or from the series.

2. ELIGIBILITY AND ENTRY

- 2.1. The regatta is open to boats of the **ORC, YRALIS PHRF, J/70, J/88, J/105, J/109, and J/44** classes. Other One Design classes may be accepted at the discretion of the Organizing Authority. The OA may reject the entry of any yacht that does not in its sole discretion meet the general parameters of the other yachts entered with respect to size or design.
- 2.2. **Short Course Racing (Windward/Leeward)**: Boats may choose to race in one of the following classes:
 - a) **ORC Fleet**: Boats shall have a valid **ORCi or ORC Club certificate, and a GPH rating of 660 or less.**
 - b) **One Design**
- 2.3. **Coastal Racing (Government Marks)**: Boats may choose to race in one of the following classes:
 - a) **PHRF**: Boats shall have a valid **YRALIS PHRF certificate with a rating of 165 or less.**
 - o A sub-class "**PHRF Non-Spinnaker**" will be scored for boats racing **without using a spinnaker.**
 - b) **ORC Doublehanded**: Boats shall have a valid **ORC DH certificate.**
 - c) **Leukemia Cup**: Boats with or without a valid YRALIS PHRF certificate, with or without a spinnaker. Boats without a valid YRALIS PHRF certificate will be assigned a rating by the Organizing Authority.
- 2.4. ORCi, ORC Club, ORC DH, and PHRF Rating Certificates must be available on the issuing Rating Authority's website no later than 1800 on Thursday, September 22, 2022.
- 2.5. Online registration and electronic entry fee payment are available on the **regatta website** at <https://yachtscoring.com/emenu.cfm?eid=15021>.
- 2.6. The entry form, entry fee, and rating certificate (when applicable) shall be submitted online on or before **1800 on Saturday, September 17, 2022.** Late entries along with late fees may be accepted until 1800 on Thursday, September 22, with permission from the OA. **No entries will be accepted after 1800 on Thursday, September 22.**
- 2.7. All boats entered will automatically be given a Leukemia Cup fundraising webpage.
- 2.8. All competitors shall complete and submit the online liability waiver prior to the close of entries.

3. FEES

- 3.1. The Fall Regatta entry fee for **ORC Fleet and One Design** is \$350.
- 3.2. The Fall Regatta entry fee for **PHRF, PHRF Non-Spinnaker, and ORC Doublehanded** is \$300.
- 3.3. The entry fee for the **Leukemia Cup** only is \$50.

- 3.4. The entry fee for the **J/105 New England Championship** only is \$250.
- 3.5. **Late entry fee:** A late fee of \$50 will be charged for entries received after **1800 on Saturday, September 17**.
- 3.6. **Administration fee:** Boats withdrawing after 1800 on Saturday, September 17, and before 1800 on Thursday, September 22, will be refunded their entry fee minus a \$25 administration fee. Boats withdrawing after 1800 on Thursday, September 22, will not receive a refund.
- 3.7. **Late rating certificate fee:** A late certificate fee of \$50 will be charged for rating certificates filed after 1800 on Saturday, September 17. No certificates or changes to certificates will be accepted after 1800 on Thursday, September 22 without the permission of the OA.

4. SCHEDULE

- 4.1. Racing for all classes in the **Fall Regatta** is scheduled for **September 24, 25 and October 1, 2**.
- 4.2. Racing for the **Leukemia Cup** is scheduled for **September 24** only.
- 4.3. Racing for the **J/105 New England Championship** is scheduled for **October 1, 2** only. J/105 class boats may enter the Fall Regatta and also race on September 24, 25.
- 4.4. The first warning signal on each day will be based on the weather forecast and will be at **1055 or 1255**. The Race Committee will announce by text message and post on the regatta website the time of the first warning signal by 1900 on the day before each day of racing.
- 4.5. For the **Short Course Racing** classes, multiple races per day are scheduled.
- 4.6. For the **Coastal Racing** classes, one race per day is scheduled.

5. SAILING INSTRUCTIONS

Sailing Instructions will be available on the regatta website by 1200 on the day before the first race.

6. VENUE

Races will be conducted on two separate courses from starting areas located approximately mid-Sound, south or east of Milton Point, Rye, New York. The approximate positions of the starting areas will be announced approximately 40 minutes prior to the first warning signal each day for all classes on their respective VHF channels.

7. COURSES

- 7.1. **Short Course Racing** classes will sail windward-leeward courses with drop marks.
- 7.2. **Coastal Racing** classes shall sail daytime distance courses around government and drop marks.

8. PENALTY SYSTEM

- 8.1. RRS Appendix T shall apply.
- 8.2. US Sailing Prescription Appendix V, Rule V1 shall apply.
- 8.3. Rule 61 will be changed to require boats to notify the Race Committee of their intent to protest.

9. SCORING

- 9.1. One Race is required to constitute a series.
- 9.2. When fewer than 5 races have been completed, a boat's series score will be the total of her race scores. When 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 9.3. Scoring for ORC Fleet will use Windward/Leeward ToT Triple Number ratings and scoring in the ORC Doublehanded class will use All Purpose ToT Triple Number ratings shown on their certificates.
- 9.4. Scoring for PHRF will use ToD and the Distance rating shown on their certificates.
- 9.5. The series score for the **Fall Regatta** shall be based on race scores from **September 24, 25 and October 1, 2**.
- 9.6. The series score for the **Leukemia Cup** shall be based on race scores from **September 24**.
- 9.7. The series score for the **J/105 New England Championship** shall be based on race scores from **October 1, 2**.
- 9.8. The series score for the **J/100** class boats sailing in the Coastal Racing, PHRF Non-Spinnaker sub-class shall be based on race scores from **September 24, 25**, and separately from the overall Fall Regatta.

- 9.9. For every \$100 raised before 1800 hours on September 22 by a boat participating in the **Leukemia Cup** only, that boat will be awarded a rating adjustment benefit of 1 second per mile towards their finish time in that event, up to a maximum of 20 seconds per mile.

10. CLASSES

Boats will be placed into classes (designated by numbers 1, 2, 3, etc.) at the discretion of the Race Committee. A listing of entrants by class and starting area (south, southeast, or east of Milton Point) will be available on the regatta website by 1200 on the day before the first race and from the Race Committee support boats in the starting areas. **Each boat shall display the numeral pennant for its class on its permanent backstay or, in the absence of a permanent backstay, from its stern rail. [DP]**

11. RADIO COMMUNICATION

Each boat shall carry a radio capable of transmitting and receiving VHF channels 16, 69, and 71. Except in an emergency or to report a protest or withdrawal, a boat shall neither make nor receive any type of electronic communication while racing that is not freely available to all boats. [DP]

12. DINNER

American YC will host a Leukemia Cup dinner and paddle raise on the evening of Saturday, September 24. Dinner tickets must be purchased separately for \$250 per person, or a table for \$2,500. More information is available at <https://events.ils.org/home/diylcr/AYC>. Members of American YC may purchase tickets on the club website, and non-members may call (914) 967-4800 to purchase tickets via credit card.

13. PRIZES

Prizes will be awarded at American Yacht Club after the final race and protest hearings. Series prizes for each class in the Fall Regatta will be awarded as follows: first place prize for two or more entries; second place for four or more; and third place for six or more. The JOYETTE, ZILPH, and CYNOSURE TROPHIES will be awarded to the boats which, in the judgment of the Race Committee, have the best performance in the PHRF, One Design, and ORC divisions respectively. The ROGER SHERMAN MEMORIAL TROPHY will be awarded to the boat which, in the judgment of the Race Committee, has the best combined performance in the Spring Regatta and Fall Regatta.

Prizes for the Leukemia Cup will be awarded during the dinner at American Yacht Club on September 24, as follows: first place in the Leukemia Cup race; first, second, and third place boat based on the amount of fundraising.

Series prizes for the J/105 New England Championship will be awarded as follows: first place, second place, and third place.

14. RESPONSIBILITY FOR SAFETY, WAIVER & RELEASE

By participating in this event and any related activity sponsored, undertaken, administered, managed, or allowed to be conducted by American Yacht Club, the owner, helmsman and each crew member agree, understand and accept, for themselves and their respective successors, assigns, representatives, administrators, executors, agents, heirs or any person acting or purporting to act on their behalf ("Releasors") that sailing is an inherently dangerous and unpredictable activity due to multiple factors that cannot be anticipated or predicted with certainty, including but not limited to weather, equipment failure or malfunction, and the actions of others on or off the water, injury, sickness and disease (including communicable diseases such as Covid-19). Releasors also agree, understand and accept that sailing presents inherent risks of serious bodily injury (including permanent disability, paralysis, and death, whether by drowning or otherwise, sickness and disease (including communicable diseases), property damage and other economic loss. Accordingly, and in consideration for being permitted to enter into and participate in this or any other sailing event sponsored, undertaken, administered, managed or allowed to be conducted by

American Yacht Club, Releasors forever release and waive, to the fullest extent allowed by law, any and all claims, actions, accounts, causes of action and choses in action, whether in law, equity or admiralty, that Releasors now have, may have had or may come to have, against American Yacht Club, including its officers, directors, trustees, members, employees, agents, volunteers, staff, committees, and anyone acting on its behalf (“Releasees”), for anything arising out of or relating to Releasors’ participation in such sailing events (including contracting communicable diseases such as Covid-19). Notwithstanding anything to the contrary, and without in any way limiting or lessening the effect or breadth of the foregoing release and waiver, and solely for the avoidance of doubt and clarification, Releasors agree, acknowledge and understand that this release and waiver applies to any and all claims of any kind at all against Releasees arising out of or relating to injuries, deaths, sickness and disease (including communicable diseases such as Covid-19), damage to vessels or damage to personal property sustained during or as a result of any and all sailing events sponsored, undertaken, administered, managed or allowed to be conducted by American Yacht Club.
