Notice of Race: AMENDMENT 1.1

This notice is to inform regatta entries as of 3/24 that the NOR for the Midwest Sport boat Regatta has been revised.

The amended NOR was posted on 3/24/2022 at the relevant Yachtscoring.com page the Midwest Sport boat Regatta.

All regatta entries prior to 3/24 will be sent an updated NOR via email. All entries prior to 3/24 should review the changes.

- 1.4** 1.4 was removed: The Racing Rules will be modified as follows: (a) If there is a conflict between this notice and the Sailing Instructions, the latter will take precedence was removed.
- 2.1** Was modified to: "relevant" page on yachtscoring.com
- 3.1** Was modified to: The online official notice board will be located at relevant Yachtscoring.com event page.
- 3.2** Channels 22 and 68 were added.
- 4.1** Was modified to: Classes eligible for this event are defined as monohull or multihull sailboats with a minimum length of 18'. Boats that do not meet the length requirement may contact the Race Chair to be considered" replaced the previous version.
- 4.3** Was added: Classes will be allocated to divisions based on boat type and assigned rating into an Open Sportboat Division and a Racer/Cruiser division.
- 4.4** Was added: Before participating in this event, every owner, competitor, and support person shall sign a Waiver of Liability on relevant Yachtscoring.com event page.
- 4.5** Was added: Eligible boats may enter by completing the entry form found on the relevant Yachtscoring.com event page and paying their registration fees.
- 5.1** Entry fee for Racer/Cruiser Class was changed to \$125.
- 6.2** Was modified to: A Competitors meeting will be held at the grassy area north of the main marina parking lot on June 11, 2022, at 0900 hrs.
- 6.3.1** Was modified to: A total of 8 races are scheduled for the Open Sportboat Class.
- 6.3.2** Was modified to: A total of 2 distance races are scheduled for the Racer/Cruiser Class.
- 6.3.3** Was removed
- 6.4** Was added: On the last day scheduled day of racing no warning will be made after 1400 hrs.
- 7.1** Was modified to: The location for racing will be the navigable water on Saylorville Lake between the dam and bridge.

- 10.2 Was modified to: Each boat shall be assigned a rating that is based on the PHRF rating system. Ratings will be based on the Midwest PHRF (MWPHRF) rating database. Participants can present a valid MWPHRF certificate, but a certificate is not required. If a boat does not have a MWPHRF rating the OA will assign a rating, based on information available on the US Sailing PHRF web page
- 10.2.1 Was added: Corrected times will be calculated using Time-on-Time correction, using the correction factor appropriate for average conditions.
- 10.2.2 Was added: Any One Design (OD) class of 4 or more boats sailing under their respective OD class rules may be given their own Start.
- 10.2.3 One race is required to be completed to constitute a series.
- 10.3 Was removed

- 11.3 Was added: Before participating in this event, every owner, competitor and Support Person shall sign a Waiver of Liability on Yachtscoring.
- 13.2 Was modified to: A perpetual travelling trophy will be awarded to the boat with the best overall corrected time within the Open Sportboat Class.
- 13.3 Was modified to: A perpetual travelling trophy will be awarded to the boat with the best overall corrected time within the Racer/Cruiser class.
- 14. Was modified to: Regatta Contacts only. Lodging and additional information will be available on a separate document at the relevant page on yachtscoring.com
