[DP] The notation '[DP]' in a *rule* means that the penalty for a breach of the *rule* may, at the discretion of the protest committee, be less than disqualification.

1 RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 The current PHRF Regulations as administered by the YRA of LIS will apply.
- 1.3 Boats shall observe the current US Sailing Special Equipment Requirements for Nearshore races, however section 2 and 3 shall not apply to boats not designed and equipped with: pulpits, stanchions, lifelines or self-bailing cockpits.
- 1.4 Rule V1, Penalty at the Time of an Incident, will apply.
- 1.5 Appendix T, Arbitration, will apply as changed below:After the last sentence of appendix T4, Arbitration Meeting Outcomes, add the following:If a protest hearing is held, the arbitrator will not be a member of the panel that hears the protest but will be permitted to observe the testimony presented and offer evidence. This changes rule T4 and rule 63.3(a).

2 SAILING INSTRUCTIONS

Copies will also be available during the event at the hospitality desk.
- 2.2 Scratch sheets will be available on YachtScoring.com no later than 1800, Friday, July 15, 2022.

3 COMMUNICATION

- 3.1 Notices to competitors will be posted on the official notice board (ONB) located online at https://yachtscoring.com/notice_board.cfm?eid=15314
- 3.2 Each boat shall carry a VHF radio capable of communicating on VHF channel 73.
- 3.3 On the water, the race committee will make courtesy broadcasts to competitors on VHF radio. The channel will be 73.
- 3.4 [DP] While racing, from the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4 ELIGIBILITY AND ENTRY

- 4.1 The event is open to Offshore One Design Racer-Cruisers and Non-Spinnaker Boats. At the discretion of the race committee, some divisions may be divided into separate classes. Non-Spinnaker Boats will race with the *Expressly for Fun* fleet for the first weekend's racing, and with other PHRF boats on the second weekend.
- 4.2 For those classes not sailing One-Design under class rules, entries shall be accompanied by a valid YRALIS PHRF certificate.
- 4.3 Any boat registered for Expressly for Fun Spinnaker or Non Spinnaker that also enters the Execution Rocks race will remain in the same division.
- 4.4 Eligible boats may enter by registering online at <u>https://yachtscoring.com/event_registration_email.cfm?eid=15314</u> no later than Wednesday, July 13, 2022. Entries accepted after that time are subject to a \$25.00 late fee.
- 4.5 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.

5 FEES

The entry fee is \$175.00.

For boats racing only in the Expressly for Fun event on the first weekend, the entry fee is \$125.00 For boats racing only in the Execution Rocks Race on July 24, the entry fee is \$75.00. For boats racing in the Expressly For Fun Regatta and the Execution Rocks Race, the Entry Fee is \$175.00

The entry fee includes admission to the dance Saturday, July 23 and awards presentation.

6 SCHEDULE OF EVENTS

- 6.1 No later than 0930 each day, the race committee will announce via Yacht Scoring the scheduled first warning time of either the earlier initial 1st warning or the latter option.
- 6.2 The first warning for the Expressly for Fun Event will be either 1100 or 1300 on Saturday, July 16, and Sunday, July 17.
- 6.3 For all other PHRF Divisions the first warning will be either 1200 or 1400 each day.

7 VENUE

The racing area will be in the waters off Larchmont Harbor.

8 COURSES

- 8.1 The **Expressly for Fun** Event on Saturday, July 16, and Sunday, July 17, will be a Pursuit Race around government buoys.
- 8.2 **Courses for the PHRF Divisions** on Saturday, July 16, Sunday, July 17, and Saturday, July 23, will be windward/leeward as described in the sailing instructions.

On Sunday, July 24, the course for all Divisions will be the Execution Rocks Race.

If a class elects to opt out of the Execution Rocks Race for a windward/leeward course, they shall notify the race committee no later than 1200, Wednesday, July 13.

9 SCORING

- 9.1 One race is required to be completed to constitute a series.
- 9.2 A boat's series score will be the total of her race scores, without exclusion.
- 9.3 Boats will be scored for the Execution Rocks Race in the same division as they registered for the 1st weekend.
- 9.4 For PHRF, time allowances will be computed using Time on Distance
- 9.5 Rule A5.3 applies.

10 PRIZES

- 10.1 Series prizes will be awarded for first, second and third places in each division. Awards will be given for the best elapsed time and best corrected time in the Execution Rocks Race.
- 10.2 Perpetual trophies will be awarded at the discretion of the race committee.
- 10.3 A boat which sets a new elapsed time course record in the Execution Rocks Race will receive a case of Mt. Gay Rum. The elapsed time record is 39 minutes 51 seconds, set by Christopher Dragon on 23 July, 2017.
- 10.4 This regatta is a qualifying event for the YRA Youth Challenge Cup, Gitano, Sappho, Competitors, Kings Point and Allegra Knapp Mertz awards.
- 10.5 Prizes will be awarded following the completion of racing on Sunday, July 24, on the front lawn.

11 GUEST MOORING AND PRIVLEGES

- 11.1 Guest moorings will be available on a first-come basis at no charge through <u>Dockwa</u>
- 11.2 Limited privileges of the Club will be extended to skippers and crews for Larchmont Race Week.

12 COVID-19 PROTOCOLS

4 ELIGIBILITY AND ENTRY

- 5.1 Most of the boats sailing in this event are expected to be owned by skippers' yacht clubs. Skippers are encouraged to arrange with their own clubs to sail boats owned by their clubs.
- 5.2 For skippers who are unable arrange to boats owned by their clubs, the OA and other area yacht clubs will make their Ideal 18s available for charter on a first-come basis. Boat charter must be selected during online registration. There is a \$100 per boat charter fee, in addition to the registration fee set forth in section 6.
- 5.3 Boat charters will be managed by the OA. Participants will be notified of the boat they will sail at registration. Chartered boats are provided "as is" and will include sails and all required safety equipment. Charterers are encouraged to provide their own sails and to inspect their boats prior to sailing to determine if they wish to add any spare or extra gear.

9 COURSES

The course(s) to be sailed will be windward/leeward, as described in the sailing instructions.

10 SCORING

- 10.1 One completed race in any of the three events (June, July, August) will constitute a regatta for that event.
- 10.2 In order to qualify for the Ideal 18 Summer Regatta Series, a skipper must compete in Larchmont Race Week in July and at least one of the other events (either the June or August event). A skipper who competes in all three events will discard either June or August, whichever is worse.
- 10.3 Scoring for June 11 & Aug 13 will be high-point without exclusion. Scoring for Race Week will be low point without exclusion.
- 10.4 Scoring for the series will include the results from the Larchmont Race Week, converted to high point, plus the results for the skipper's best of the one-day regattas. The series score for each boat will be a percentage calculated as follows: divide the sum of her race scores by the sum of the points she would have scored if she had placed first in every race in which she competed; multiply the result by 100. The qualifying boat with the highest series score is the winner, and others are ranked accordingly.
