SAILING INSTRUCTIONS

The Notation "DP" means that a penalty for a breach of that rule may, at the discretion of the Protest Committee, be less than disqualification

1 RULES

- 1.1 The Race Committee will publish a scratch sheet listing the class breakdowns, the boats assigned to each class, and the class flags. The order of starts will be published as an addendum to the Sailing Instructions. These will be posted on the online Official Notice Board by 1600 on Wednesday, June 14, 2023. The responsibility of the assignment of a boat to a class resides solely with the Race Committee.
- 1.2 The Official Notice Board shall be located on Yacht Scoring at https://www.yachtscoring.com/emenu.cfm?elD=15515.

2 NOTICES TO COMPETITORS

- 2.1 Notices to competitors will be posted on the Official Notice Board.
- 2.2 A skippers' meeting for the 'Round-the-Sound will be held at 1700 on Wednesday, June 14, 2023 at the EYC Clubhouse.

3 CHANGES TO SAILING INSTRUCTIONS

- 3.1 Any Changes to the Sailing Instructions (SI) will be posted before 0800 on the day they will take effect, except that any change to the schedule of the race will be posted by 2000 on the day before it will take effect.
- 3.2 In the event of a Shore AP, changes to the Sailing Instructions can be made up until 15 minutes before AP is hauled down.

3.3 Oral changes to the Sailing Instructions may be given on the water on VHF Channel 72 per RRS 90.2(c).

4 SIGNALS MADE ASHORE

- 4.1 Signals made ashore will be displayed from the Club station mast.
- 4.2 When flag AP is displayed ashore, "1 minute" is replaced with "not less than 60 minutes" in the race signal AP. When a class flag is displayed with the AP, it applies to that class only.

5 COURSES

- 5.1 Courses will be chosen by the Race Committee each day based upon forecasted weather and current conditions.
- 5.2 Courses will be described on an Addendum to the Sailing Instructions.
- 5.3 Different courses may be assigned by class and/or division.
- 5.4 Each day's course(s) will be published on the Official Notice Board no later than 0900 on the day of racing.

6 THE START

- 6.1 The starting line will be between a staff displaying an orange-colored flag on the Race Committee signal boat at the starboard end and the course side of an inflatable mark at the port end of the line.
- 6.2 (DP) Boats whose warning signal has not been made shall avoid the starting area while other classes are in start sequence.
- 6.3 A boat starting later than five minutes after its starting signal will be scored Did Not Start (DNS) without a hearing. This changes RRS A4.
- 6.4 If any part of the boat's hull is on the course side of the starting line at the starting signal, the Race Committee will attempt to broadcast its sail number on VHF channel 72. Failure to make a broadcast will not be grounds for a request for redress. This changes RRS 62.1(a).
- 6.5 The starting signal boat may use a "stand-off" buoy at the starting line. The "stand-off" buoy is considered part of the committee boat.
- 6.6 When at a boat's starting signal she is subject to RRS 29.1 *Individual Recall* and she fails to comply with RRS 29.1 to start correctly, the Race Committee shall, without a hearing, apply a corrected time penalty of 10 minutes and she shall be deemed to have started correctly. Should the Race Committee consider this penalty to be inappropriate, it shall protest the boat. This changes RRS 28.1, RRS 63.1, and A5.

7 THE FINISH

The finishing line will be between a staff displaying a blue flag on the Race Committee signal boat at the starboard end of the line and the course side of an inflatable mark at the port end.

8 PENALTY SYSTEM

8.1 RRS 44.3, *Scoring Penalty*, will be in effect. The Scoring Penalty shall be a 2 percent addition to its corrected time. This changes RRS 44.3(c). The

requirement to display a yellow flag is waived. This changes RRS 44.3(a) and (b).

8.2 POST RACE PENALTIES

(a) Provided that 44.1 (b) does not apply, a yacht that may have broken one or more rules of Part 2 or RRS 31 in an incident may take a Post-Race Penalty at any time after the race until the beginning of a protest hearing involving the incident.

(b) A Post-Race Penalty shall be a 4 percent addition to its corrected time. (c) A boat takes a Post-Race Penalty by delivering to the race office a written statement that she accepts the penalty and that identifies the race and where and when the incident occurred.

8.3 RRS 64.2 is changed to include: "The protest committee may impose penalties other than disqualification, including time penalties, for breaches of a rule."

9 TIME LIMIT

Boats failing to finish within 4 hours of their start will be scored Did Not Finish (DNF) without a hearing. This changes RRS 35.

10 PROTESTS AND REQUESTS FOR REDRESS

- 10.1 A yacht intending to protest is requested to report its intent to protest to the Race Committee signal boat within 10 minutes following its finish. Such notification will include the sail number of the boat being protested.
- 10.2 Electronic protest forms are available on the Official Notice Board. Paper protest forms are available at the Race Committee office. All protests and requests for redress or reopening shall be delivered in-person to the Race Committee office within the appropriate time limit.
- 10.3 The protest and request for redress time limit is 1 hour after the Race Committee signal boat arrives at their dock. The same time limit applies to protests by the Race Committee and the Protest Committee about incidents they observe in the racing area and to requests for redress. This changes RRS 61.3 and 62.2.
- 10.4 Notices will be posted electronically on the Official Notice Board no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses.
- 10.5 Protests will be heard in the EYC Wardroom starting 30 minutes after the protest time limit expires. This is subject to modification by the Chief Judge on a case-by-case basis.
- 10.6 Requests for scoring reviews must be submitted electronically, in person, or by calling the EYC Race Office no later than the protest time limit. This deadline may be extended on a case-by-case basis at the discretion of the Race Committee or Protest Committee.
- 10.7 (DP) Breaches of SI 12, 13, and RRS 47 *Trash Disposal* will not be grounds for a protest by a boat. This changes RRS 60.1(a). Penalties for these breaches may be less than disqualification, if the Protest Committee so decides.

11 SCORING

The decision on the scoring method and scoring parameters used will be at the sole discretion of the Race Committee and together with length of course, directions of leg and the wind speed will not be grounds for request for redress by a boat. This changes RRS 60.1(b).

12 SAFETY

- 12.1 Refer to the Safety and Emergency Protocol information provided on the Official Notice Board.
- 12.2 (DP) Prior to the first warning signal each boat will contact the Race Committee as they pass Edgartown R "8" on VHF Channel 73, and check in by announcing to the Race Committee its name, class, sail number, and number of souls on board. The Race Committee will respond with the sail number heard. Upon completion of check-in, boats shall shift their radios back to VHF Channel 72 for the duration of the race.
- 12.3 (DP) The Chappaquiddick Ferry shall be considered "Restricted in her ability to maneuver," as defined in COLREGS Rule 18, and as such has the right-of-way over power driven and sailing vessels underway.
- 12.4 (DP) Any boat withdrawing before the start or retiring during the Race for any reason SHALL NOTIFY THE RACE COMMITTEE on VHF Channel 72 AND the Race Committee Office by telephone (508) 627-4364.

13 RADIO COMMUNICATIONS

- 13.1 Radio communications between competitors and the Race Committee will be on VHF Channel 72, with the exception of check-in on VHF Channel 73.
- 13.2 Boats being raced double-handed may make intra-boat radio communications while racing.
- 13.4 (DP) Except in an emergency or to communicate with the Race Committee, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

14 PRIZES

Prizes will be awarded as described in the Notice of Race at 0900 on Sunday, June 18, 2023. A Zoom link will be provided on the Official Notice Board.

1 RULES

- 1.1 The Race Committee will publish a scratch sheet listing the class breakdowns, the yachts assigned to each class, and the class flags. The order of starts will be published as an addendum to the Sailing Instructions. These will be posted on the online Official Notice Board by 1600 on Friday, June 16, 2023. The responsibility of the assignment of a yacht to a class resides solely with the Race Committee.
- 1.2 The Official Notice Board shall be located on Yacht Scoring at https://www.yachtscoring.com/emenu.cfm?eID=15515.

2 NOTICES TO COMPETITORS

- 2.1 Notices to competitors will be posted on the Official Notice Board.
- 2.2 A skippers' meeting for the 'Round-the-Island will be held at 1700 on Friday, June 16, 2023 at the EYC Clubhouse.

3 CHANGES TO SAILING INSTRUCTIONS

- 3.1 Any Changes to the Sailing Instructions (SI) will be posted before 0600 on the day they will take effect, except that any change to the schedule of the race will be posted by 2000 on the day before it will take effect.
- 3.2 In the event of a Shore AP, changes to the Sailing Instructions can be made up until 15 minutes before AP is hauled down.
- 3.3 Oral changes to the Sailing Instructions may be given on the water on VHF Channel 72 per RRS 90.2(c).

4 SIGNALS MADE ASHORE

- 4.1 Signals made ashore will be displayed from the Club station mast.
- 4.2 When flag AP is displayed ashore, "1 minute" is replaced with "not less than 60 minutes" in the race signal AP. When a class flag is displayed with the AP, it applies to that class only.

5 CLASS FLAGS

- 5.1 (DP) Each yacht shall fly from her stern, at least five feet above the deck, an international code flag numeral pennant corresponding to the number of the class to which she has been assigned. Yachts lacking a backstay will do their best to comply. Multi-hulls are exempt from this requirement. The pennant will be flown from the time the yacht checks in per SI 15.2 until the yacht has finished and cleared the finishing area. Only the Race Committee may protest a yacht for breaking this requirement. This changes RRS 60.1, 60.3, and 60.4.
- 6.2 (DP) Racing yachts shall not fly an ensign. Only the Race Committee may protest a yacht for breaking this requirement.

6 THE COURSE

The course will be a clockwise circumnavigation of Martha's Vineyard from Edgartown , and will be sailed in Nantucket Sound, the Atlantic Ocean, and Vineyard Sound. The distance is approximately 55 nautical miles. The approximate course, with virtual gates, is depicted in Addendum #1 to these sailing instructions. This course is a test of seamanship and navigation skills. Competitors are reminded that the course passes adjacent to several shoals and reefs. Caution should be exercised throughout the Race with special attention given in the area east and south of Wasque Point on the southeast corner of Chappaquiddick Island where strong currents have occasionally forced racing yachts to anchor while awaiting favorable conditions. Use of engine propulsion to safely navigate any part of this course violates RRS 42 and yachts that engage their engines should retire or face protest and potential disqualification.

7 MARKS

After the start, the following are the marks of the course in sequence. All marks will be left to Starboard with the exception of the finish mark as described in SI 10.

- Start Edgartown C "3"
- Inflatable Yellow Mark (Will be set approximately 1.3 NM NNE of Cape Pogue in position: 41 26.4N, 070 26.2 W).
- Mutton Shoal G C "3"
- Muskeget Channel RW "MC", Mo(A)
- Squibnocket Point N "2"
- Devil's Bridge G "31"
- West Chop C "25"
- East Chop G "23"
- Finish Edgartown R "2"

8 THE START

- 8.1 The starting line will be between a staff displaying an orange-colored flag on the Race Committee signal boat at the port end and C "3" at the starboard end of the line.
- 8.2 (DP) Yachts whose warning signal has not been made shall avoid the starting area while other classes are in start sequence.

- 8.3 A yacht starting later than five minutes after its starting signal will be scored Did Not Start (DNS) without a hearing. This changes RRS A4.
- 8.4 If any part of the yacht's hull is on the course side of the starting line at the starting signal, the Race Committee will attempt to broadcast its sail number on VHF channel 72. Failure to make a broadcast will not be grounds for a request for redress. This changes RRS 62.1(a).
- 8.5 The starting signal boat may use a "stand-off" buoy at the starting line. The "stand-off" buoy is considered part of the committee boat.
- 8.6 When at a yacht's starting signal she is subject to RRS 29.1 *Individual Recall* and she fails to comply with RRS 29.1 to start correctly, the Race Committee shall, without a hearing, apply a corrected time penalty of 20 minutes and she shall be deemed to have started correctly. Should the Race Committee consider this penalty to be inappropriate, it shall protest the yacht. This changes RRS 28.1, RRS 63.1, and A5.

9 COURSE GATE AND SHORTENED COURSE PROCEDURES

- 9.1 (DP) Yachts shall record on their gate time sheet their time to the nearest second per their GPS when they pass through the finish line and each "course gate" as described in SI Addendum 1. Yachts should attempt to note on the gate time sheet the sail numbers of the yachts immediately ahead and astern of them as they pass through the gate.
- 9.2 (DP) Yachts shall submit their gate time sheets as soon as reasonably possible after finishing or retiring, but not later than 2400 on Saturday, June 17, 2023. Gate time sheets can be submitted in person to the Race Office, or by texting a photo of the gate time sheet to (978) 618-7385.
- 9.3 The Race Committee may shorten the course at any of the course gates described in SI Addendum 1. Shortened course decisions will be made for each individual class.
- 9.4 In the event of a shortened course, the Race Committee shall announce on VHF channel 72 and will post on the Official Notice Board which classes are having their courses shortened, and at which gate(s) each class will finish. This changes RRS 32.
- 9.5 The Race Committee may make a shortened course announcement at any time before or after the first yacht of a class has passed through the shortened course gate for that class. This changes RRS 32.
- 9.6 Yachts that fail to finish before time expires, or retire prior to reaching the finish line or the shortened course finish gate for their class, will be scored based upon their reported time at the last gate through which they successfully passed before they retired or time expired.

10 THE FINISH

- 10.1 (DP) Yachts finishing shall hail the Race Committee on VHF Channel 72 five minutes before their estimated finishing time stating their yacht name and sail number.
- 10.2 The finishing line will be between a staff displaying a blue flag on the Race Committee signal boat at the starboard end of the line and Edgartown Buoy R "2" at the port end.
- 10.3 Deep keeled yachts with safety concerns about leaving R "2" to port at the finish may declare their intent to leave R "2" to starboard and finish within a 100 yard extension of the finish line. They must make this declaration when checking in per SI 10.1.
- 10.4 (DP) Yachts shall record their own finishing time to the nearest second per their GPS, and provide that information to the Race Committee on Addendum 1. (See SI 9.1-9.2).
- 10.5 After sunset the Race Committee boat at the finish line will display an anchor light and the Club's night signal, red over green over red. Yachts finishing after sunset will illuminate their sail numbers on the side closest to the Race Committee boat while crossing the finishing line and for at least 30 seconds following the finishing signal from the Race Committee boat.

- 10.6 If there is fog at the finish, the Race Committee boat may ring a bell rapidly for approximately five seconds at intervals of not more than one minute.
- 10.7 In the event that there is no Race Committee boat on station at the finishing line, a yacht shall finish and take its own time in accordance with the US Sailing prescription to RRS 34. A yacht shall finish within 100 yards of R "2" with the mark bearing 050M or 230M from the racing yacht, and report its finishing time and finishing position in relation to any nearby yachts and report them to the Race Committee as soon as reasonably possible, but no later than 2400 on Saturday, June 17, 2023.

11 PENALTY SYSTEM

- 11.1 RRS 44.3, *Scoring Penalty*, will be in effect. The Scoring Penalty shall be a 2 percent addition to its corrected time. This changes RRS 44.3(c). The requirement to display a yellow flag is waived. This changes RRS 44.3(a) and (b).
- 11.2 POST RACE PENALTIES
 (a) Provided that 44.1 (b) does not apply, a yacht that may have broken one or more rules of Part 2 or RRS 31 in an incident may take a Post-Race Penalty at any time after the race until the beginning of a protest hearing involving the incident.

(b) A Post-Race Penalty shall be a 4 percent addition to its corrected time.

(c) A boat takes a Post-Race Penalty by delivering to the race office a written statement that she accepts the penalty and that identifies the race and where and when the incident occurred.

11.3 RRS 64.2 is changed to include: "The protest committee may impose penalties other than disqualification, including time penalties, for breaches of a rule."

12 TIME LIMIT

- 12.1 Yachts failing to finish by 2400 on Saturday, June 17, 2023 will be scored for finishing at the last gate through which they successfully passed before time expired. This changes RRS 35.
- 12.2 Yachts failing to successfully pass Gate 1 before time expires will be scored Did Not Finish (DNF) without a hearing. This changes RRS 35.

13 PROTESTS AND REQUESTS FOR REDRESS

- 13.1 A yacht intending to protest is requested to report its intent to protest to the Race Committee signal boat within 10 minutes following its finish. Such notification will include the sail number of the yacht being protested.
- 13.2 Electronic protest forms are available on the Official Notice Board. Paper protest forms are available at the Race Committee office.
- 13.3 Protests and requests for redress must be delivered electronically via YachtScoring or in person to the EYC Race Office before 0730 on Sunday, June 18, 2023. The same time limit applies to protests and requests for redress by the Race Committee and the Protest Committee about incidents they observe in the racing area.
- 13.4 Notices will be posted electronically on the Official Notice Board as soon as practicable, but no later than 0800 Sunday, June 18, 2023 to inform competitors of redress requests and/or hearings in which they are parties or named as witnesses. Hearings will be held remotely by telephone conference call, or in person in the EYC Wardroom (as posted on the Official Notice Board.)
- 13.5 Requests for scoring reviews must be submitted electronically, in person, or by calling the EYC Race Office prior to 0730 on Sunday, June 18, 2023. This deadline may be extended on a case-by-case basis at the discretion of the Race Committee or Protest Committee.

- 13.6 Protests and requests for redress will be heard in approximately the order in which they are received beginning at 0830 on Sunday, June 18, 2023, unless the parties and the Protest Committee agree to hear the case earlier.
- 13.7 (DP) Breaches of SI 15, 16, and RRS 47 *Trash Disposal* will not be grounds for a protest by a yacht. This changes RRS 60.1(a). Penalties for these breaches may be less than disqualification, if the Protest Committee so decides.

14 SCORING

The decision on the scoring method and scoring parameters used will be at the sole discretion of the Race Committee and together with length of course, directions of leg and the wind speed will not be grounds for request for redress by the yacht. This changes RRS 60.1(b).

15 SAFETY

- 15.1 Refer to the Safety and Emergency Protocol information provided on the Official Notice Board.
- 15.2 (DP) Prior to the first warning signal each yacht shall contact the Race Committee as they pass Edgartown R "6" on VHF Channel 73, and check in by announcing to the Race Committee its name, class, sail number, and number of souls on board. The Race Committee will respond with the sail number heard. Upon completion of check-in, yachts shall shift their radios back to VHF Channel 72 for the duration of the race.
- 15.3 (DP) The Chappaquiddick Ferry shall be considered "Restricted in her ability to maneuver," as defined in COLREGS Rule 18, and as such has the right-of-way over power driven and sailing vessels underway.
- 15.4 (DP) Any yacht withdrawing before the start or retiring during the Race for any reason SHALL NOTIFY THE RACE COMMITTEE on VHF Channel 72 AND the Race Committee Office by telephone (508) 627-4364.

16 RADIO COMMUNICATIONS

- 16.1 Radio communications between competitors and the Race Committee will be on VHF Channel 72, with the exception of check-in on VHF Channel 73.
- 16.2 Yachts being raced double-handed may make intra-yacht radio communications while racing.
- 16.3 (DP) Except in an emergency or to communicate with the Race Committee, a yacht shall neither make radio transmissions while racing nor receive radio communications not available to all yachts. This restriction also applies to mobile telephones.

17 PRIZES

- 17.1 Prizes will be awarded as described in the Notice of Race at 0900 on Sunday, June 18, 2023. A Zoom link will be provided on the Official Notice Board.
- 17.2 The Organizing Authority may choose to hold the Awards Ceremony on schedule despite protests, redress requests, and scoring inquiries that may remain unresolved.
