

Discretionary Penalty '[DP]' For infringements of the Rules other than RRS Part 2, the Jury may award a DP, unless stated otherwise in the Notice of Race, Sailing Instructions, or other documents. This changes RRS 64.2.

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1 THE RULES

- 1.1 The event is governed by the rules defined in The Racing Rules of Sailing (RRS). Appendix T. Arbitration will apply. See:

- 1.2 The Sail Canada Prescriptions to the RRS apply for the entire race, including in US waters. See: https://www.sailing.ca/wp-content/uploads/2022/06/sail_canada_prescriptions_2021_2024_14_03_2022.pdf
- 1.3 Sail Canada is the appeal authority for this event, including for incidents in US waters.
- 1.4 The event is also governed by: R2K Offshore Special Regulations (OSR).
 - The event is a Category 3 Event under the World Sailing Offshore Special Regulations for Category 3 for Monohulls with prescriptions from Sail Canada and amended by the R2K. This is documented in R2K Offshore Special Regulations for Category 3 for Monohulls (R2K OSR). This document will be available at the R&DWS under *Documents & Forms*.
- 1.5 The Racing Rules will be changed as outlined below. The Sailing Instructions (SIs) may also change other RRSs.
- 1.5.1 RRS 41 Outside Help
 - Each boat may communicate with any person, competitor, boat, or outside source for information using any means available throughout the race. This changes RRS 41.
- 1.5.2 RRS 42.3 (i) Propulsion
 - 1. Engine propulsion may be used to avoid a collision with commercial traffic providing that such usage does not advance the boat's position from its original position before the hazardous incident.
 - 2. An engine may be used to generate electrical power if such use does not advance the boat's position.
- 1.5.3 RRS 51 Movable Ballast

Canting keels and water ballast are allowed if the applicable class/measurement/handicap rules permit them. This changes RRS 51.

- 1.5.4 RRS 52 Manual Power
 - 1. All movable ballast systems must be capable of manual operation if the powered systems are inoperable.
 - 2. The use of power auto helm devices is allowed.

These change RRS 52.

- 1.5.5 [NP] RRS 62 Redress
 - 1. The Race Committee may announce boats subject to RRS 29.1 (Individual recall)
 - 2. The Race Committee may announce a boat's successful completion at the finish.

The contents of these announcements, including order or whether they are made, are not grounds for redress.

These change RRS 62.

- 1.5.6 RRS A4 Scoring System & A5 Scores Determined by the Race Committee
 - A boat not starting within 20 minutes of her starting signal will be scored DNF. This changes RRS A4 & A5.
- 1.6 RRS Appendix RV, Reduced Visibility replaces RRS Part 2 between sunset and sunrise. The appendix is available at the R&DWS under *Documents & Forms*.
- 1.7 Under World Sailing Test Rule DR21-01, the definition of *Start* is changed as follows:

- Start A boat starts when her hull has been entirely on the pre-start side of the starting line and having complied with rule 30.1 if it applies, any part of her hull crosses the starting line from the Pre-start side to the course side either:
 - (a) at or after her starting signal, or
 - (b) during the last eight minutes before her starting signal.

When a boat starts in accordance with item (b) of the definition of *Start*, she may return to the prestart side of the line to comply with item (a) of the definition of *Start*, but if she does not, the starting penalty shall be: 20 minutes shall be added to her elapsed time.

- 1.8 When RRS 20 applies, a boat may indicate her need for room to tack or her response by VHF radio on channels 16 and the specified regatta channel.
- 1.9 [NP] Within 90 minutes of finishing, boats shall electronically submit their R2K Race Log and R2K Alternative Penalty Form to R2K@MimicoCrusingClub.com These documents are available on R&DWS under *Documents & Forms*.

2 SAILING INSTRUCTIONS

2.1 The SIs will be available by Friday, August 2nd, 2024, on the R&DWS.

3 COMMUNICATION

- 3.1 The official notice board is online and located on the R&DWS.
- 3.2 VHF-FM Marine Radio
 - 3.2.1 All boats shall carry a VHF radio capable of communicating on 16 and 71 Canadian, with Dual Watch capability. The radio must be on VHF 71 (event channel) during the start sequence and throughout the race, while monitoring VHF 16 in Dual Watch mode.
 - 3.2.2 The boat's VHF Radio shall meet the requirements of the R2K OSR for the category of the race, including any applicable connection to a GPS (GNSS) receiver.
 - 3.2.3 Regardless of the applicable R2K OSR requirements around a VHF radio, If a VHF-FM marine fixed radio is DSC capable, the boat shall have a MMSI that is entered into the radio and the MMSI shall be input as part of the online registration process. If the radio is DSC capable and MMSI is not entered in the radio nor in the online registration process, then the entry is not complete.
- 3.3 As an alternative means of communications, a boat shall carry a cell phone that is kept charged while racing. The cell number shall be entered as part of the registration and updated as necessary to reflect the cell phone number carried aboard.
- 3.4 On the water, the Race Committee may make courtesy broadcasts to competitors on the specified event channel.
- 3.5 The Race Committee may make oral changes to the Sailing Instructions (SIs) on the water by the Race Committee broadcasting to competitors on the specified event channel.

4 ELIGIBILITY AND ENTRY

4.1 The third annual Race to Kingston event is limited to 60 boats on a first come, first-serve basis. The Event is open to Monohull boats with a PHRF of <u>180</u> or less in their chosen class of Flying Sails (FS) or Non-Flying Sails (NFS). Boats must meet one of the stability measurements listed in 3.04 of the R2K Offshore Special Regulations for Category 3 Monohulls (R2K OSR). A valid PHRF-LO Certificate is required to be eligible.

Classes will be:

- Flying Sails (FS) Crewed (CD)
- Non-Flying Sails (NFS) Crewed (CD)
- Flying Sails (FS) Doublehanded (DH)

Upon application and subsequent review, the OA may, at their sole discretion, accept or reject such boat as suitable for this race. The OA may request that the owner provide a boat's technical evidence to review a boat for its suitability, including stability characteristics.

Boats must be in compliance with World Sailing Offshore Special Regulations 2024-2025 for

- Category 3 Events with applicable Sail Canada Prescriptions and as modified for this event addressed collectively as "R2K OSR."
- 4.2 Eligible boats may be entered in the race by registering at the R&DWS.
- 4.3 The OA, upon application and subsequent review of the boat's technical evidence, as supplied by the owner, may, at their sole discretion, accept or reject such boat as suitable for this race. It is the responsibility of the owner to obtain and submit required technical evidence when requested by the OA, to review a boat for its suitability including stability characteristics.
- 4.4 [NP] Supporting documentation for a complete entry includes all information requested in the online entry, as well as the following:
 - 1. Full payment of the entry fee(s) online is due at the time of registration.
 - 2. R2K Boat and PiC Waiver 2024 electronically signed by PiC as part of the online registration on the R&DWS.
 - 3. R2K OSR Compliance Form submitted by email to R2K@MimicoCruisingClub.com during online registration. PiC's email address is the signature.
 - 4. If the boat's VHF radio is DSC capable, its MMSI shall be entered as part of the online registration.
 - 5. The Crew List on the R&DWS shall accurately represent the crew onboard for the race, and PiC shall always maintain the list. The PiC is crew and shall be included. The Crew List shall be completed by the end of day on Friday, August 9th.
 - 6. All crew shall agree to R2K Crew Waiver 2024, part of the mandatory crew registration in the Crew's Corner of the R&DWS.
 - 7. R2K Crew Overboard Recovery Drill Certificate (R2K CORDC). The completed form can be submitted by email to R2K@MimicoCruisingClub.com by the end of day on Friday, August 9th. Actual crew signatures are needed, whether submitted by email or in person. Crew overboard procedures shall be practiced aboard the boat at least once annually. Refer to Appendix D of the World Sailing Offshore Special Regulations for more details on COB Recovery. At least 50% of the crew (100% of the crew for Double Handed DH) entries shall participate in the Crew Overboard Recovery Drill and sign the R2K CORDC.
 - 8. A valid one or two day Sail Canada Offshore Personal Survival Course Certificate OPSCC (or equivalency dealt on case by case basis) for 15% of the crew within the last 5 years of the commencement of this race (17-August-2019). For crews of 6 or less, one person must have completed this course. For crews 7 and over 15% of the crew must have completed the course rounding up to the next full person. This must be submitted by email to R2K@mimicocruisingclub.com, by end of day, Friday, August 9th, 2024.
- 4.5 The class in which the boat intends to sail must be submitted during registration and can be changed until Friday, August 2nd, 2024. Classes may be subdivided into divisions based on the handicap system and rating. The OA may assign boats to divisions and or classes based on the number of boats registered.
- 4.6 All entries must have a valid PHRF-LO Certificate. For boats from outside the PHRF-LO area, arrangements shall be made in advance to obtain a PHRF-LO certificate by contacting PHRF-LO, www.phrf-lo.org, see NoR 19.
- 4.7 Boats shall only display a sail number registered specifically to the boat at the time of its commission unless Alternative Sail Numbers have been declared under Sail Inventory on the R&DWS.
- The OA may provide each boat with an event flag. The SIs will define how the flag will be flown in the harbour before and during the race.

5 FEES

- 5.1 For registration to be complete, full payment and all other entry requirements must be met.
- 5.2 Fees for all boats are as follows and are payable online:

\$199.00 CAD + \$25.87 CAD HST = \$224.87 CAD - Entry Fee till June 30, 2024.

or

\$259.00 CAD + 33.67 CAD HST = \$292.67 CAD - Entry Fee, July 1 - August 2, 2024.

- 5.3 Payment in full is required upon registration. Registration closes at 2359 EDT on Friday, August 2nd, 2024. Registrations without payment in full will be removed.
- If the Organizing Authority OA cancels the event by July 12th, 2024 or rejects an entry subject to eligibility requirements not being met per S4.1, the OA will refund fee paid, less \$50.00 CAD + HST to cover committed costs.
- 5.5 If the OA cancels the event after July 12, 2024, refunds will be paid, less \$100.00 + HST to cover committed costs.
- 5.6 If the event is held, a 50% refund will be granted for requests received by the OA by the end of day, August 2, 2024. No refunds will be provided after this. Written requests must be sent to Mimico Cruising Club Attention R2K Race Committee Registrar or emailed to R2K@mimicocruisingclub.com.

6 CREW LIMITATIONS & REQUIREMENTS

6.1 The following limitations apply to the crew, in addition to those in the applicable R2K OSR and class rules. The PiC is part of the crew, so all limitations and requirements on the crew applied to the PiC.

Double Handed (DH)	All crew members shall be 18 years of age or older.	
Crewed (CD)	The PiC and at least one other crew shall be 18 or older.	

7 ADVERTISING

- 7.1 Boats may be required to display advertising chosen and supplied by the OA.
- 7.2 Boats may carry advertising as permitted by RRS with no additional fee. The OA may reject any advertising that may conflict with any required advertising or with the interests of the OA or sponsors.

8 SCHEDULE

- 8.1 [NP] Registration is online until 2359 EDT, Friday, August 2nd, 2024, the registration deadline.
- 8.2 Class Organization Splits and starting sequences will be posted by 2359 on Saturday, August 10th.
- 8.3 [NP] The Mandatory Event Onsite Check-in at Mimico Cruising Club (MCC) from 1300 to 1800 EDT, Friday, August 16th, 2024. Other Race Events of Friday, August 16th, 2024 are:

1300 EDT – Event Sponsors Booths open

1645 EDT - Race Reception commences

1800 EDT – Event Dinner commences

- 8.4 [NP] The Mandatory Skippers' Meeting is at 1930 EDT, Friday, August 16th, 2024, at MCC. A representative from each boat shall attend this meeting, which is also open to all participants.
- 8.5 The warning signal for the First R2K group will be 1000 EDT, Saturday, August 17th, 2024. The warning signal for others will be made after that.
- 8.6 Sunday, August 18th Finishers Greeting at KYC
- 8.7 The deadline for finishing competitors is 0900 EDT, on Monday, August 19th. Boats finishing after this time will be scored DNF.
- 8.8 1100 Monday, August 19th, 2024 Race Awards Celebration Event and Luncheon commences.

9 EQUIPMENT INSPECTION

- 9.1 All boats shall be reviewed for the equipment listed in the R2K OSR. The PiC will undertake this review. Confirmation is submitted on R2K OSR Compliance Form: see NoR 4.4 (7) on page 5.
- 9.2 [DP] A boat may be inspected at any time during the period from the Mandatory Participants' Meeting until one hour prior to the Awards Ceremony. At the finish of the race, the Race Committee may direct a boat to proceed directly to a designated location at Kingston. A boat that fails to follow such directions or subsequently fails the inspection may be protested by the Technical Committee.
- 9.3 The Technical Committee may request a Pre-Race Inspection of a boat. 48-hour notice will be provided.

10 COURSE

10.1 The Course is: Start, one of the 9 MCC/EYC marks, Finish in the vicinity of the KYC Break wall. See Diagram 1 for the course chart.

11 PENALTY SYSTEM

11.1 The Scoring Penalty, RRS 44.3, applies.

12 SCORING

All boats will be scored with the PHRF-LO Time-on-Time scoring method. The scoring system is Low Point. Double Handed (DH) & Fully Crewed (FC) boats racing under/following a rating/handicap system, will be scored with boats in their own class based on the PHRF-LO Time-on-Time formula using PHRF-LO Alternative Formula conversion.

13 CHARTERED OR LOANED BOATS

13.1 A chartered or loaned boat may carry national letters or a sail number in contravention of her class rules, provided that the Race Committee has approved her sail identification before the race.

14 RIGHTS & DATA PROTECTION

- 14.1 [NP] All pictures, audio and video recordings, graphic logos, and service names contained herein or produced during the race by or on behalf of the OA are the property of either the OA or their respective members. No rights are granted to use pictures, graphic logos, and service names without permission.
- 14.2 [NP] Registrants, competitors, and participants grant the OA the unrestricted right and permission to use the name and image for any text, photograph, or video footage of either themselves or the boat they are sailing during the event to be published or broadcast in any media whatsoever (including but not limited to press, TV, social media, or internet), for either editorial or advertising purposes or to be used in press information.

15 RISK STATEMENT

The decision to race, or to continue racing, is the sole responsibility of the yacht (PiC and Crew). By participating in this event, each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include intense winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform, and fatigue resulting in an increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia, or other causes. By participating in this event, each competitor agrees to release the race organizers from all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

16 INSURANCE

[NP] Each participating boat shall be insured with a valid third-party liability insurance policy with a minimum coverage of \$2,000,000 CAD per event for Canadian boats and an adequate level of third-party liability insurance applicable in Canadian and US waters for non-Canadian boats. Proof of insurance may be randomly inspected.

17 PRIZES

- 17.1 Race Results will not be announced until the Awards Ceremony, following which they will be posted on Yacht Scoring.
- 17.2 Prize Flags will be awarded to the first three winning boats (PHRF-LO scoring), in each Division for the following:
 - Flying Sails (FS) Crewed (CD)
 - Non-Flying Sails (NFS) Crewed (CD)
 - Flying Sails (FS) Doublehanded (DH)

A Trophy will also be awarded for the First Place (PHRF-LO scoring) in each Division:

- Flying Sails (FS) Crewed (CD)
- Non-Flying Sails (NFS) Crewed (CD)
- Flying Sails (FS) Doublehanded (DH)

Trophies will also be awarded for:

- Line Honours (first across the finish line)
- Overall Winner (corrected time on PHRF)
- 17.3 The Awards ceremony will be at 1100 EDT, Monday, August 19th, 2023, at Kingston Yacht Club.
- 17.4 The trophies are awarded annually. Trophies will be awarded at the R2K Awards Ceremony and be available for Team photos but must be returned to the Presenter immediately following the ceremony.


Course Diagram
