NOTICE OF RACE

1 RULES

.

- **1.1** The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- **1.2** The T-Ten Class Association North American Championship Regulations (NACR) shall apply.
- **1.3** In the event of conflict between any of the above Rules and Regulations and the Sailing Instructions, the Sailing Instructions shall prevail.

2 ADVERTISING

Advertising will be restricted to Category A.

3 ELIGIBILITY

- **3.1** The regatta is open to all T-10 one design boats as defined by the T-10 Class Association rules.
- **3.2** All competitors shall comply with eligibility requirements in accordance with NACR Article 6 Eligibility.

4 ENTRY

- **4.1** An eligible boat may enter by completing an online Entry Form and paying a nonrefundable Entry Fee of \$400 not later than July 31, 2008.
- **4.2** An entry received after July 31, 2008 requires the payment of an additional late fee of \$175. No entries will be accepted after August 12, 2008.
- **4.3** Online Entry Forms are available on the event registration website at <u>www.yachtscoring.com</u>.

- **4.4** To qualify as an official contestant the following shall be lodged with the Race Office prior to the close of registration on Thursday, August 21, 2008.
 - (a) Complete Registration with Organizing Authority including Entry Form and Disclaimer duly completed, and Entry Fee paid.
 - (b) Proof of Ownership or Charter
 - (c) Crew list, weight and waivers
 - (d) Measurement Certificate
 - (e) Certificate of Insurance
 - (f) Media rights, as supplied by the Organizing Authority, signed by all of the crew
 - (g) Display hull identification and stickers as stated by the Sailing Instructions.

5 FEES

6 SCHEDULE

6.1 Registration

6.4 Number of races

A maximum of 11 races shall be sailed. The race committee reserves the right to modify the schedule due to weather conditions or other causes.

7 MEASUREMENT

- 7.1 Sails shall be measured in accordance with NACR Article 8 Sails.
- **7.2** A crew list and crew weight limit shall be instituted in accordance with NACR Article 7 Personnel On Board.

8 SAILING INSTRUCTIONS

The sailing instructions will be available at registration at the Chicago Corinthian Yacht Club.

9 LAUNCHING

Launching services will be provided at Chicago Corinthian Yacht Club. Boats desiring to use the launching service are requested to make arrangements with the Organizing Authority prior to August 2, 2008.

10 VENUE

Racing area will be upon the open waters of Lake Michigan east of Montrose Harbor.

11 THE COURSES

The courses to be sailed shall be in accordance with NACR Article 11 – Courses.

12 BERTHING

Boats shall be kept in their assigned places in Montrose Harbor unless prior written approval has been obtained from the organizing authority.

13 HAUL-OUT RESTRICTIONS

Boats shall not be hauled out during the regatta except with and according to the terms of prior written permission of the race committee.

14 TRACKING DEVICES

A boat may be required to carry a tracking device supplied by the Organizing Authority. Failure to carry and operate a tracking device may lead to rejection of an application for entry, the cancellation of an entry or the disqualification of the boat from the race (refer RRS 76.1).

15 HULL IDENTIFICATION

- **15.1** The Organizing Authority will supply hull identification stickers that shall be attached to each boat as directed by the Organizing Authority.
- **15.2** Sponsor or other regatta stickers may be required to be attached to each side of each boat as required by the Organizing Authority.

16 PRIZES

- **16.1** The following perpetual trophies and awards are to be given:
 - North American Championship Trophy
 - Sparkman Stephens Performance Trophy
 - Charlie Britton Memorial Award
 - Elaine and Wes Pignolet Award
- **16.2** Prizes for first through fifth place overall and for first through third in each individual race will be awarded.

17 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4 Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

18 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000 per event or equivalent.
