### NOTICE OF RACE

Saturday, June 8 – Sunday, June 9, 2024

Organizing Authority: Seawanhaka Corinthian Yacht Club (SCYC).

#### **1 RULES**

The regatta will be governed by the rules as defined in the 2021-2024 Racing Rules of Sailing, except where noted in this NOR, Sailing instructions or the Viper 640 Class Association Class Rules.

#### **2 ELIGIBILITY AND ENTRY**

- 2.1 The event is open to boats of the Viper 640 Class.
- 2.2 Competitors may enter by delivering a completed entry form and paying the entry fee to Seawanhaka Corinthian Yacht Club either in person or the event website at <https://yachtscoring.com/emenu.cfm?eid=15360>
- 2.3 Registration shall be electronically, via event website on yachtscoring.com or in person at the Seawanhaka Corinthian Junior Club starting at 10:00 on June 8, 2024.
- 2.4 The entry fee is \$100 US

#### **3 NOTICES TO COMPETITORS & CHANGES IN THE SAILING INSTRUCTIONS**

Notices to competitors will be posted on the official notice board, which is located on the West side of the Junior Club building and on the event website. Changes to the Sailing Instructions shall be posted by 11:00.

#### **4. SCHEDULE**

- 4.1 A competitors' meeting shall be held at 12:30 on Saturday, June 8th at the Junior Club. The warning signal for the first race will be at 13:30 on June 8th and 11:00 on June 9th. No race will be started after 15:30 on June 9th.
- 4.2 A light dinner and beer will be provided on June 8<sup>th</sup> following racing.

#### **5. SAILING INSTRUCTIONS (SIs)**

The SIs will be available at the skippers meeting and on the SCYC and event website.

#### **6. BERTHING**

Moorings will be available for yachts for the event starting on Friday, June 7<sup>th</sup>. Trailer storage will also be available.

## **7 VENUE**

All events will take place at Seawanhaka Corinthian Yacht Club, Centre Island, NY. The race course area will be in Oyster Bay/Cold Spring Harbors.

## **8 COURSES AND MARKS**

The courses and marks will be as described in the SIs.

## **9 PROTESTS**

Boats intending to protest or request redress shall notify the signal boat after finishing the race during which the incident occurred. This modifies RRS 61.3. Protests may be filed on the event website or at the Seawanhaka Junior Club. Hearing schedule will be posted on the notice board and on the event website.

## **10 ARBITRATION and ALTERNATIVE**

US Sailing Prescription Appendix T-Arbitration shall be offered. US Sailing Appendix V-Appendix V Alternative Penalties sections V1 and V2 will be applied.

## **11 SCORING**

One (1) completed race constitutes a series. A boat's worst score shall be excluded if 5 races are sailed.

## **12 PRIZES**

Prizes will be awarded to the top three overall finishers.

## **13 DISCLAIMER OF LIABILITY**

Competitors participate in the regatta entirely at their own risk. See Rule 3 Decision to Race. The Organizing Authorities will not accept any liability for material damage or personal injury or death sustained in conjunction with, or prior to, during, or after the regatta..
