1. Rules

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 The rules of the International J/22 Class Association will apply.
- 1.3 International J/22 class rule 8.9 (crew weight) will not be enforced for this event.

2. Eligibility and Entry

- 2.1 The regatta is open to all boats meeting the International J/22 Class Association Requirements
- 2.2 Eligible boats may enter by completing the on line entry form at https://www.yachtscoring.com/emenu.cfm?eID=4630 through July 31, 2018. Payments will be through Yacht Scoring
- 2.3 Late entries, at an additional fee, will be received until August 17, 2018

3. Fees

- 3.1 The registration fee for the 2018 Tawas Bay of Pig's Regatta and J22 Michigan Championship is \$100.00 USD. Late entry as noted in 2.3 will be \$130.00 USD
- 3.2 Entry includes dinner for 3 persons on Saturday and free keg of beer on Saturday

4. Schedule of Racing and Events

- 4.1.1 Saturday, 8/18/2018 11:00am Competitors' Meeting
- 4.1.2 Saturday, 8/18/2018 12:30pm Warning Signal of first of up to 4 races
- 4.1.3 Sunday, 8/19/2018 11::00am Warning Signal of first of up to 3 races. No warning signal after 2:00pm

5. Sailing Instructions

5.1 The Sailing Instructions will be available at registration.

6. Venue

6.1 The course will be located within Tawas Bay approximately 1 mile NW of the Tawas Bay Yacht Club harbor.

7 The Course

7.1 The course will be windward leeward, twice around as described in the Sailing Instructions.

8 Penalty System

8.1 The 720 degree penalty system as described in RRS 44.1 and 44.2 will apply.

9 Scoring

9.1 When 5 or more races have been completed, a boats series score will be the total of her scores excluding her worst score

10 Support Boats

10.1 Support boats are required to register with the Race Committee.

11 Berthing

11.1 Boats are to be kept in their assigned dry sail area when ashore.

12 Prizes

12,1 Prizes will be awarded for first through fifth place. The highest placing Michigan boat will receive the annual J22 Michigan Championship trophy.

13 Disclaimer of Liability

13.1 Competitors participate in the regatta entirely at their own risk. See RRS Rule 4, Decision to Race. Neither the organizing authority nor the hosts will accept any Liability for material damage or personal injury or death sustained in conjunction with, or prior to, during, or after the regatta.

14. Insurance

14.1 Each participating boat shall be insured with a valid third party Liability insurance with a minimum coverage of \$300,000.
