

# JILÀSI FOR YOUTH REGATTA



Saturday, September 22, 2018

An inaugural regatta celebrating Broad Reach Foundation's 20 years of fostering potential in disadvantaged youth through the sport, science and experience of sailing

#### NOTICE OF RACE

The National Yacht Club is the Organizing Authority for the regatta.

#### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* 2017-2020.
- 1.2 The regatta is a single pursuit race, at which the following rule changes apply:
- 1.2.1 Boats are not required to be afloat and off moorings at the preparatory signal. This changes Rule 45.
- 1.2.2 Boats will start according to individual start times allocated. This changes Rule 26.
- 1.2.3 A boat that has not finished more than 60 minutes after the first boat to finish will be scored Did Not Finish without a hearing. This changes Rules 35 and A4.2.
- 1.2.4 Race committee broadcasts regarding its intentions, the course to be sailed, start times, course changes, etc. are a courtesy only. Failure of the race committee to make a broadcast, the timing of a broadcast, or the failure of a boat to hear a broadcast shall not be grounds for redress. This changes Rule 60.1(b).
- 1.2.5 A party to a hearing may ask for a reopening no later than 10 minutes after being informed of the decision. This changes Rule 66(b).
- 1.2.6 Cruising boats without sail numbers confirming to Appendix G will be required to carry signage with numbers assigned by the race committee. This changes Rule 77.
- 1.3 In case of discrepancy between the notice of race and the sailing instructions, the sailing instructions will apply.

### 2 ELIGIBILITY AND ENTRY

- 2.1 The regatta is open to all PHRF-LO rated boats. Boats without a valid PHRF-LO certificate at the time of registration will be assigned a rating valid only for the regatta.
- 2.2 There is an entry limit of 50 boats. Additional entries may be accepted at the sole discretion of the race committee.
- 2.3 Eligible boats may enter by registering online at <a href="www.sailbroadreach.ca/regatta">www.sailbroadreach.ca/regatta</a>.
- 2.4 All entries must be received no later than 5 pm on Monday, September 17, 2018. Late entries may be accepted at the sole discretion of the race committee.
- 2.5 As a condition of entry, each skipper shall sign a liability waiver on behalf of themself and all members of their crew. The liability waiver form shall be submitted prior to racing at check in. The liability waiver form will be available online at https://yachtscoring.com/emenu.cfm?eID=4749.

## 3 FEES

- 3.1 The entry fee is \$100.00 plus HST, payable to Broad Reach Foundation for Youth Leaders.
- 3.2 Entry is complete with the submission of all forms and payment of fees.

### 7 THE COURSE

7.1 The course will be between five and eight nautical miles in length, west of Toronto Islands around National Yacht Club marks and/or government buoys.

### 8 RADIO COMMUNICATIONS

8.1 The race committee will operate on VHF channel 72, and will monitor VHF channel 16.

#### 9 PRIZES

- 9.1 The Hans Fogh Trophy will be awarded to the first boat to finish.
- 9.2 The Broad Reach Foundation Jilàsi for Youth Trophy will be awarded to the boat whose crew has raised the largest donation online to benefit the Broad Reach Foundation for Youth Leaders.

## 10 DISCLAIMER OF LIABILITY

10.1 Competitors participate in the racing entirely at their own risk. See rule 4, Decision to Race. The Organizing Authority expressly disclaims any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 11 INSURANCE

11.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$2 million per incident. A copy of the policy shall be kept on board.
