NOTICE OF RACE

8/24/2018 - final

1. ORGANIZING AUTHORITY

1.1. The Organizing Authority (OA) is The Corinthian Yacht Club Of Philadelphia (CYCOP).

2. RULES

- 2.1. The regatta will be governed by the *rules* as defined in The Racing Rules of Sailing for 2017-2020 (RRS) including the prescriptions of US Sailing except as modified by the Sailing Instruction
- 2.2. Class rules which may prohibit the use of VHF radios while racing are waived for the duration of this event for the purpose of safety and for receiving pertinent race information
- 2.3. Where there is a conflict between this Notice of Race (NOR) and the Sailing Instructions (SIs), the SIs shall prevail except that neither shall change nor alter any class rules except that which is listed in NOR 2.2. This changes RRS 63.7.

3. ADVERTISING

- 3.1. Advertising is permitted in accordance with ISAF Regulation 20 and applicable class rules
- 3.2. Boats are strongly urged to refrain from displaying advertising that may conflict with event sponsors.

4. ELIGIBILITY

- 4.1. Entry is open to all eligible sailboats in the following classes: J22, and V15.
- 4.2. A minimum of 5 boats must be registered by September 23 at 1800 to constitute a class
- 4.3. If minimum entry requirement is not satisfied, that class may be canceled at the discretion of the OA.

5. ENTRY

5.1. Entry for all boats will be accepted through online registration at www.yachtscoring.com. Entry fees are:

5.1.1.	J22	\$30
5.1.2.	V15	\$25
5.1.3.	Food and refreshments	\$15 per person

- 5.2. <u>All regatta entries must be made on-line at www.yachtscoring.com. No registrations will be</u> accepted at the regatta on Saturday morning
- 5.3. All official forms and notices will be on-line at yachtscoring.com and we will be utilizing their email and text message system for communicating important information to participants
- 5.4. Any fleet announcements will be made on Yacht Scoring website and delivered by email and text to the skippers as listed in yachtscoring.com
- 5.5. A boat is not considered entered in the regatta until it has paid the appropriate entry fee and completed the on-line waiver

6. SCHEDULE OF EVENTS

6.1. It is the intent of the OA and the Race Committee (RC) to conduct up to six races

7. MEASURMENT

7.1. Measurement requirements will be in adherence to individual class rules

8.1. Sailing Instructions will be available online at <u>www.yachtscoring.com</u> by 1800 on September 27, 2018

9. COURSES AND RACING AREA

- 9.1. Racing will be held on the Delaware River off The Corinthian Yacht Club Of Philadelphia (Boeing Bay)
- 9.2. Specific course details will be outlined in the Sailing Instructions

10. SCORING

- 10.1. The Low Point Scoring System as described in RRS Appendix A will apply
- 10.2. One race shall constitute a series
- 10.3. A boat's worst finish may be discarded after a class has completed five races

11. **PRIZES**

11.1. Prizes will be awarded based on the number of entrants for each class

12. CODE OF CONDUCT

- 12.1. All competitors, coaches, and family members are expected to behave in a sportsmanlike manner. This includes behavior both on and off the water including respect for all other persons, personal property of others, and the facility. Any competitor who violates this trust in any manner, including the consumption of beer or other alcoholic beverage by a minor, may be penalized by the OA and/or have a complaint lodged against him or her by the Protest Committee
- 12.2. Penalties imposed by the OA or the Protest Committee may include disqualification of the boat with which the competitor is associated, notification of law enforcement and/or parents, or other penalties the Protest Committee or the OA may deem appropriate

13. EVENT HEADQUARTERS

13.1. Event Headquarters is at The Corinthian Yacht Club Of Philadelphia

14. MEDIA RIGHTS

14.1. Competitors give absolute right and permission for video footage and photographs of themselves, their crew or their boat to be published in any media for press, editorial, or advertising purposes or used by CYCOP for promotional purposes

15. DISCLAIMER OF LIABILITY

15.1. Sailing is an activity that carries with it an inherent risk of damage and injury, even death. Competitors participate in this regatta entirely at their own risk and are reminded to pay special attention to RRS 4, Decision to Race

15.2. The race organizers, including the Organizing Authority, Race Committee, Protest

Committee, sponsors, volunteers or any other affiliated organization or official will not be responsible for damage to any boat or other property, or the injury to any competitor, including death, sustained as a result of practice for or participation in this event on the water or ashore

15.3. By participating in the event, each competitor agrees to release the race organizers from any and all liability associated with such competitor participation in this event to the fullest extent permitted by law
