Organizing Authority: The Golden Gate Yacht Club, San Francisco, California

Rules:

- This Regatta will be governed by the rules as defined in the Racing Rules of Sailing 2009-2012, the SF Bay Knarr Association class rules, the Knarr Assoc. 50th Anniversary Notice of Race and the Sailing Instructions.
- Competitors shall wear PFD's while racing; this changes rule 40 in the RRS.

Eligibility and entry:

- All Members of the SF Bay Knarr Association in good standing.
- This form is available at www.ggyc.com on the race deck page under "Schedule". On-line registration is preferred. Registration may also be made by mailing the entry form, and payment made payable to GGYC, to GGYC, 1 Yacht Road, San Francisco CA 94123. ATTN: Race Office.
- The entry fee is \$40.00 for the regatta.
- If fewer than 10 boats register by 1500 Friday September 30, 2011 the regatta may be cancelled.

Schedule of Races:

- The regatta will be held Sunday October 2, 2011.
- The warning signal will be at 1200 hrs.
- The Race Committee will attempt to run at least 3 or more races.

Racing Area and Courses:

- The starting line will be the orange placard on the GGYC race deck and Buoy X.
- Races will be sailed on the City Front.

Sailing Instructions:

- Copies will be available at Golden Gate Yacht Club no later than 1700 on September 30, 2011, as well as on the GGYC web site: www.ggyc.com
- Changes to the Sailing Instructions shall be posted on the official notice board located at the end of the bar in the Burgee Room and on the web site no later than 1000 hours on the day they are to take effect.

Scoring:

• The Low-Point Scoring System, RRS Appendix A, will apply.

Prizes:

Trophies will be awarded by the SF Bay Knarr Association after the last race.
