NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Boats shall observe the current Minimum Equipment Recommendations of YRA of LIS, Race Category C. However section 2, Structural Features, does not apply to boats not designed and equipped with pulpits, stanchions, lifelines or self-bailing cockpits.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Rule V1, Penalty at the Time of an Incident, will apply.
- 1.5 Appendix T will apply as changed below:
 At the end of T4, Arbitration Meeting Outcomes, add: (c) If a protest is not withdrawn after arbitration, the arbitrator will not be a member of the jury that hears that protest but will be permitted to observe the testimony presented and offer evidence. This changes rule 63.3(a).

2 ELIGIBILITY AND ENTRIES

- 2.1 The regatta is open to PHRF and Offshore One Design Racer-Cruisers and Non-Spinnaker Boats. At the discretion of the race committee, some divisions may be divided into separate classes.
- 2.2 Eligible boats may enter by registering online at Yacht Scoring: http://www.yachtscoring.com and submitted no later than 2359, Wednesday, July 10, 2019. Entries accepted after that time are subject to a \$25.00 late fee.
- 2.3 The Entry Fee is \$150.00 which includes after sailing lawn parties, awards ceremony and guest moorings on a first come basis. See the Social Calendar for details
- 2.4 For those classes not sailing One-Design under class rules, entries shall be accompanied by a valid PHRF or IRC rating certificate. PHRF certificates from other areas may be adjusted to conform to the YRA of LIS systems.

- 3.1 The racing area will be in the waters off Larchmont Harbor.
- 3.2 The first warning will be at 1255 each day.

- 4.1 Sailing instructions will be available no later than 1800 Thursday, July 11, posted online at: www.larchmontyc.org and http://www.yachtscoring.com. They also will be available at the Hospitality Desk during the event.
- 4.2 Scratch sheets will be available online as listed above no later than 1800 Friday, July 12 and at the Hospitality Desk during the event.

5 SCORING

- 5.1 One completed race constitutes a series.
- 5.2 A boat's series score will be the total of her race scores without exclusion.
- 5.3 For PHRF, time allowances will be computed using Time on Distance.

6 PRIZES

- 6.1 Series prizes will be awarded for first, second and third places in each division. Awards will be given for the fastest elapsed time and fastest corrected time in the Execution Rocks Race.
- 6.2 Perpetual trophies will be awarded at the discretion of the race committee.
- A boat which sets a new elapsed time course record in the Execution Rocks Race will receive a case of Mt. Gay Rum. The elapsed time record is 39 minutes 51 seconds, set by Christopher Dragon on 23 July 2017.
- 6.4 This regatta is a qualifying event for the YRA Youth Challenge Cup, the Gitano, Sappho, Competitors, Kings Point and Allegra Knapp Mertz awards.

NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Coast Guard-approved personal flotation must be worn by skipper and crew at all times while on the water, except briefly while changing or adjusting clothing or personal equipment. This changes rule 40 and the preamble to the Part 4 rules.
- 1.3 Appendix V1, Penalty at the Time of an Incident, will apply.
- 1.4 All boats shall carry a VHF radio.

2 ENTRY AND FEE

- 2.1 The series is open to any Ideal 18 with bottom paint.
- 2.2 There are three one-day regattas within this series, Sat, June 8; Sun, July 14 during Larchmont Race Week, and Sat, August 10.
 - To qualify for the series prizes, a skipper must sail in the Larchmont Race Week regatta plus one of the other one-day regattas.
- 2.3 Eligible boats shall enter online by 1200 the Friday before the regatta. For races on June 8 and August 10, boats must enter at: https://larchmontyachtclub.formstack.com/forms/2019_ideal18_summerseries. For boats sailing during Larchmont Race Week (July 14 boats must enter at: https://yachtscoring.com/event_registration_email.cfm?eid=6240
- 2.4 The entry fees are: \$150.00 for all three days, or \$50 for individual events.

3 BOATS

- 3.1 A limited number of boats may be available for use by non-LYC sailors. To request a boat, please contact Nicky Souter, Waterfront Director at ideal18@larchmontyc.org.
 - a) All non-LYC sailors using LYC boats will be required to provide a damage deposit of \$1000.00. A valid credit card must be presented prior to the competitors' meeting.
 - b) A maximum of \$1000.00 will be charged for each incident that results in damage or loss of equipment. No charge will be made without prior notification. If two boats are involved, the damage will be allocated: to the skipper losing the protest, to both skippers if the right-of-way boat is found in violation of rule 14, or to the skipper of the damaged boat(s) if no protest is filed.
 - c)Borrowed boats will be assigned by lottery. If another club has loaned boats to LYC for this event, members of that club shall have first draw against his/her club's boats.

7 RACE AREA

The racing area will be in the waters off Larchmont Harbor.

8 SCORING

One completed race in any of the three events (June, July, August) will constitute a regatta for that event.

- In order to qualify for the Ideal 18 Summer Regatta Series, a skipper must compete in Larchmont Race Week in July and at least one of the other events (either the June or August regatta). A skipper who competes in all three events will discard either June or August, whichever is worse.
- 8.3 Scoring for June 8 & Aug 10 will be high-point without exclusion. Scoring for Race Week will be low point without exclusion.
- 8.4 Scoring for the series will include the results from the Larchmont Race Week, converted to high point, plus the results for the skipper's best of the one-day regattas. The series score for each boat will be a percentage calculated as follows: divide the sum of her race scores by the sum of the points she would have scored if she had placed first in every race in which she competed; multiply the result by 100. The qualifying boat with the highest series score is the winner, and others are ranked accordingly.

9 PRIZES

- 9.1 Prizes for the series will be awarded to the top three finishers after racing on August 10.
- 9.2 Prizes for Larchmont Race Week will be awarded on July 14, on the front lawn.
