Wayzata Yacht Club (WYC) - Apostle Islands Station (AIS) Bayfield Wisconsin, USA

NOTICE OF RACE

The notation [DP] in a rule in the Notice of Race means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

The notation [NP] in a rule in the Notice of Races means that breaches in this rule will not be grounds for a protest by a boat. This changes RRS 60.1 (a).

Code of Conduct. The registered competitor shall be responsible for conduct of the entire crew before, during, and after the Race while at Race related locations for Race related events. See RRS 2 and 69.

1. RULES

- 1.1. The series will be governed by the *Rules* as defined in the Racing Rules of Sailing (RRS).
- 1.2. Each boat shall also comply with the following [DP]:
 - 1.2.1. All U.S. Coast Guard and other applicable governmental laws, rules and regulations.
 - 1.2.2. The 2019 WYC/AIS Safety Equipment Requirements, which can be found at www.wyc.org/ais, and the Yachtscoring.com page for each event.
- 1.3. The Racing Rules will be changed as follows:
 - 1.3.1. Any use of a waypoint, defined by latitude and longitude coordinates, that the course requires a boat to leave on a specified side shall be in accordance with World Sailing Appendix WP. This appendix changes RRS 18 and RRS 28 and adds a definition of a waypoint. Appendix WP can be found at the relevant Yachtscoring.com event page.
 - 1.3.2. Appendix A2.1 is changed by Item 11.1.
 - 1.3.3. RRS 60.1(b) is changed by Item 6.2.
- 1.4. In accordance with RRS 44.1, Appendix V1 will apply.
- 1.5. Bayfield Race Week and Around the Islands Race will be conducted under their own, separate NOR and SI. These two events are included in this NOR for the sole purpose of respective series and overall season scoring.

2. ADVERTISING

2.1. All competitor or boat advertising shall be in compliance with World Sailing Regulation 20.

3. ENTRIES / ELIGIBILITY [NP] [DP]

3.1. Boats shall enter the Buoy Fleet, Mid-distance (MD) Fleet, Jib and Main (JAM) Fleet or Multihull Fleet and sail courses as described in NOR 9.

- 3.2. The races are open to boats that meet all the following requirements:
 - 3.2.1. All monohull boats shall be seaworthy and self-righting sailboats 20 feet in length or greater,
 - 3.2.2. For monohull boats 24 feet or less, lifelines (or lack thereof) per the manufacturer's/Class specifications are permitted.
 - 3.2.3. All multihull boats shall be seaworthy and be a minimum of 24 feet in length.
 - 3.2.4. Each boat shall have a functioning GPS receiver capable of displaying the boat's latitude and longitude position while racing.
 - 3.2.5. Each boat shall have a functioning VHF radio capable of monitoring Channels 16 and 72.
 - 3.2.6. All boats shall have a working motor appropriate for the size of the boat.
- 3.3. All eligible boats shall enter by delivering a completed entry form at the relevant Yachtscoring.com event page or by handing to OA prior to the radio call of the day of race.
- 3.4. All entries and fees shall be received, acknowledged, and accepted by OA prior to the VHF radio call competitors' meeting 90-minutes prior to the scheduled warning signal.
- 3.5. JAM Fleet. To be eligible to compete in the JAM Fleet, boats are limited to jib and main only.
- 3.6. Minimum Number of Crew and Use of Autopilot.
 - 3.6.1. MD and JAM Fleets: The minimum number of crew is 2 (skipper +1). Autopilots and power winches may be used in MD and JAM Fleets.
 - 3.6.2. Buoy Fleet and Multihull Fleet: The minimum number of crew is 3 (skipper +2), except boats 24 feet and under may be sailed by 2 persons (skipper +1). Autopilots and power winches shall not be used in Buoy Fleet or Multihull fleet.
 - 3.6.3. Single/Double-Handed Race: All boats may use autopilots and power winches for the single/double handed race.

4. FEES

- 4.1. Required fees are nonrefundable see Appendix 1
- 4.2. Fees are included with fleet dues for current WYC/AIS fleet members.

5. SCHEDULE

- 5.1. See Appendix 2
- 5.2. OA will hold a competitors' meeting by means of a VHF radio call approximately 90-minutes prior to the scheduled warning signal on each day.
- 5.3. On the last scheduled day of a racing event, no warning signal shall be made after 1400 hours.

6. **MEASUREMENT**

- 6.1. Each boat shall have a valid 2019 Lake Michigan PHRF (LMPHRF) Certificate.
- 6.2. If a PHRF Fleet boat does not present a valid LMPHRF rating certificate prior to the first race of the event a PHRF rating for this boat will be assigned by the OA. The assigned handicap rating will not be subject to redress. This changes RRS 60.1(b).

7. SAILING INSTRUCTIONS

7.1. Sailing Instructions will be available at relevant Yachtscoring.com event page prior to the first race of the season. Competitors are expected to obtain all relevant race documents on their own.

8. VENUE

8.1. Racing may be held in the vicinity of the Apostle Islands, except the "Silver Bay Scramble" will start in or near Apostle Islands and race to Silver Bay.

9. COURSES

- 9.1. Buoy Fleet
 - 9.1.1. This fleet may sail a combination of Windward/Leeward courses using drop marks and mid-distance courses that use any combination of drop marks, fixed marks, islands, or virtual marks indicated by GPS coordinates.
- 9.2. MD and JAM fleet
 - **9.2.1.** These fleets may use the starting line for the Buoy Fleet to start and then sail a course that uses any combination of drop marks, fixed marks, islands, or virtual marks indicated by GPS coordinates.
- 9.3. Multihull fleet
 - **9.3.1.** At the discretion of the Race Committee the Multihull fleet may sail a course as described in item 9.1.1 or a course described in item 9.2.1.

10. PENALTY SYSTEM

- 10.1. RRS Appendix V1 will apply for all fleets.
- 10.2. RRS Appendix T Arbitration will be in effect for the series.

11. SCORING

11.1. A boat's series score will be the total of her race scores. No race shall be excluded. This changes RRS Appendix A2.1.

12. RADIO COMMUNICATION

- 12.1. All official radio communications shall be made on VHF channel 72.
- 12.2. Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication, by any device that is not available to all boats. [DP]

13. PRIZES

- 13.1. Prizes will be specified in the relevant sailing instructions
- 13.2. To be eligible for end of season prizes, skipper or owner shall be a registered and paid Full or Skipper member of WYC (including membership dues and membership certificate fee as applicable) and shall be a registered and paid member of the AIS fleet, excluding payment of dues waived by AIS fleet vote or policy.

14. DISCLAIMER OF LIABILITY, WAIVER AND RELEASE OF LIABILITY

14.1 Sailing is an activity that has an inherent risk of damage and injury, including without limitation bodily injury, personal injury, permanent disability, and death. Each person (including without limitation owner, skipper, crew, spectators, officials, volunteers and others) participates in each race, social event, and/or associated activity(ies) entirely at his/her **own risk**. See RRS 4, "Decision to Race".

14.2 ORGANIZING AUTHORITY, RACE COMMITTEE, PROTEST COMMITTEE, SPONSORS, HOST CLUB AND VENUE (AND EACH OF THEIR RESPECTIVE OFFICERS, DIRECTORS, EMPLOYEES, CONTRACTORS, OFFICIALS, MEMBERS, GUESTS, VOLUNTEERS, REPRESENTATIVES AND ALL OTHER PERSONS IN THEIR CAPACITY OF ASSISTING A RACE, SOCIAL EVENT AND/OR ASSOCIATED ACTIVITIES) (COLLECTIVELY, "RACE ORGANIZERS") WILL NOT BE RESPONSIBLE OR LIABLE FOR ANY ACTION, CLAIM OR SUIT (COLLECTIVELY, "CLAIMS") OR LIABILITY, LOSS, DAMAGE, ACCIDENT OR INJURY WHATSOEVER (INCLUDING BODILY INJURY, PERSONAL INJURY, PERMANENT DISABILITY OR DEATH) (COLLECTIVELY, "DAMAGES") TO ANY PERSON, PROPERTY OR BOAT WHETHER CAUSED BY, ARISING OR RESULTING FROM THEIR ACT, ERROR, OMISSION OR ALLEGED NEGLIGENCE OR MISCONDUCT, WEATHER OR SEA CONDITIONS, HAZARDS OF ANY KIND, DEFECTS OR FAILURE OF BOATS TO BE SEAWORTHY IN HULL, RIGGING OR GEAR, OR ANY ACTS, ERRORS OR OMISSIONS OR ALLEGED NEGLIGENCE OR MISCONDUCT OF RACE ORGANIZERS OR OTHER PARTICIPANTS OR BOATS WHICH MAY OCCUR DURING OR ARISING OUT OF OR IN CONNECTION WITH ANY RACE, REGATTA, EVENT, CRUISE, SPECTACLE, SOCIAL EVENT, RACE FACILITIES OR ANY ACTIVITY SCHEDULED, SPONSORED OR AIDED IN WHOLE OR IN PART BY ANY RACE ORGANIZER(S), TO THE FULLEST EXTENT PERMITTED BY LAW.

14.3 BY PARTICIPATING, EACH PARTICIPANT (AND IN THE CASE OF CHILDREN AND MINORS, EACH PARTICIPANT'S PARENT OR GUARDIAN) FOREVER WAIVES, DISCHARGES AND RELEASES ANY AND ALL CLAIMS WHATSOEVER AGAINST RACE ORGANIZERS FOR ANY DAMAGES TO ANY PERSON, PROPERTY OR BOAT (I) SUSTAINED IN CONJUNCTION WITH OR PRIOR TO, DURING, OR AFTER EACH RACE, SOCIAL EVENT AND ASSOCIATED ACTIVITIES; OR (II) ARISING, RELATING OR RESULTING FROM USE OF RACE FACILITIES OR PARTICIPATION IN ANY RACE, SOCIAL EVENT OR ASSOCIATED ACTIVITIES, TO THE FULLEST EXTENT PERMITTED BY LAW.

14.4 PARTICIPANT <u>RELEASES</u> ALL **RACE ORGANIZERS** FROM ALL **CLAIMS** ON ACCOUNT OF GIVING ASSISTANCE, AID, CARE, ADVICE, RESCUE, FIRST AID, TREATMENT OR SERVICES.

14.5 OWNERS AND SKIPPERS OF ALL PARTICIPATING BOATS ARE REQUIRED TO INFORM ALL CREWMEMBERS OF THIS DISCLAIMER OF LIABILITY AND RELEASE **OF LIABILITY** AS A CONDITION OF ENTRY.



15. INSURANCE

15.1. All boats shall maintain Liability Insurance in full force and effect during Racing which will include a General Liability policy written by a reputable insurance company insuring the owner and any operators against liability for bodily injury in limits of not less than \$300,000 and for property damage of not less than \$100,000. Each boat will present proof of insurance upon OA's request.

16. PUBLICITY AND PHOTOGRAPHER'S RIGHTS

16.1. As a condition of participation, each participant (on behalf of him/herself and their children and minors) grants OA, sponsors and their designated photographers the perpetual, irrevocable right, license and permission to use, publish and distribute the participant's name, photos, video, images and statements of them and their boat and crew in all forms and media worldwide (including without limitation Internet) for any purposes whatsoever (including without limitation advertising, promotions, sales of pictures, etc.) without compensation or further permission.

17. FURTHER INFORMATION

- A1.1. AIS annual fleet dues of \$305 shall be paid prior to the event to qualify for season WYC trophies.
- A1.2. In the year a member joins the WYC as a FULL member, a Membership Certificate of \$400 is required. When a member joins the AIS fleet in the same year as becoming a FULL member of WYC, the AIS fleet dues are waived for that year.
- A1.3. AIS Fleet encourages all skippers and crew become US Sailing members.
