



**2019 East Greenwich Yacht Club Annual Regatta**

This event is designed to celebrate one-hundred and ten years of sailing at the East Greenwich Yacht Club for cruising boats. At least four classes will be run, a Spinnaker Class, a Non-spinnaker Class, J22 One Design, and a Family Cruising Class for those yachts optimized for cruising. Based on participation, some classes may be split. A dinner including the Annual Regatta awards ceremony will be held at the East Greenwich Yacht Club on Saturday evening. For those yachts participating from yacht clubs outside of Greenwich Bay, moorings will be provided free of charge on a first come first serve basis for both Friday, July 12th and Saturday July 13th in close proximity of EGYC.

**NOTICE OF RACE**

**1 RULES**

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing 2017-2020.
- 1.2 Principles of PHRF Narragansett Bay. <http://www.phrf-nb.org/>
- 1.3 Under rule 87 International J/22 Class Association Class Rules the class rule 8.9 will be changed as follows: The J22 crew weight is not in effect.
- 1.4 If there is a conflict between these documents the Sailing Instructions and any amendments thereto shall govern.

**2 ADVERTISING**

- 2.1 Boats may be required to display advertising chosen and supplied by the organizing authority.

**3 ELIGIBILITY AND ENTRY**

- 3.1 The Annual Regatta is a Cruising Class “Pursuit Race” around government buoys and special marks for cruising class yachts with starting times staggered according to the yachts PHRF rating or rating as determined by the club measurer.
- 3.2 The regatta is open to boats of the Spinnaker, Non-spinnaker, J22, and Family Cruising Class class(es) that meet the following qualifications:
  - a) All Spinnaker Class competitors having a valid 2019 PHRF-NB rating certificate.
  - b) All Non-spinnaker Class competitors must have a valid 2019 PHRF-NB rating certificate.
  - c) All J22s sailing in their one-design configuration.
  - d) All Family Cruising Class competitors must either have a valid 2019 PHRF-NB rating certificate or be a yacht eligible for a PHRF-NB rating. If a Family Cruising Class competitor does not have a PHRF-NB 2019 rating they may apply to the EGYC Measurer for a rating that is valid for this event only. Any Family Cruising Class competitor, with or without a PHRF-NB certificate, may apply to the EGYC Measurer for a rating adjustment that is valid for this event only. These rating adjustments may be made for any reason, including but not limited to the

materials, age, condition, or limits of the sails, the condition of the yacht's bottom, or the yacht's optimization for cruising. Rating adjustments may also be given for crew limitations; such as limited crew numbers, crew members all of one family, or use of a young crew. Family Cruising Class competitors are eligible for a 3 seconds per mile rating adjustment by having one or more crew, 18 years of age max, who are currently enrolled in a sailing program. A letter or email should be addressed to the EGYC Measurer describing any aspect of the yacht which the owner/skipper believes should be used to adjust the rating. If the yacht does not have a 2019 PHRF-NB certificate a letter or email must be addressed to the EGYC measurer describing the yacht's manufacturer, model, size, sail sizes and propulsion as early as possible. 3.3 Any one design classes may be added at the discretion of the organizer.

3.4 Eligible boats may enter by completing the online registration together with the required fee, to [www.yachtscoring.com](http://www.yachtscoring.com) by 5 days prior to the race as listed in this notice of race.

3.5 Late entries will be accepted under the following conditions: Discretion of the East Greenwich Yacht Club Race Committee Chairman. No transactions will be allowed on the water. A valid rating certificate and all fees and other required documents must accompany late registrations to be considered.

3.6 This race is a qualifier for the NBYA Boat of the Year Trophy. <http://nbya.org/racing/boty/>

#### 5 SCHEDULE

5.1 Skippers Meeting: Friday, July 12, 2019 from 1800 To 1900 at East Greenwich Yacht Club.

5.2 Cruising Class will sail a "Pursuit Race", one race is scheduled for Saturday, July 13, 2019. Cruising Class "Pursuit Race" around government buoys and special marks for cruising class yachts with starting times staggered according to PHRF rating with family and friends as crew encouraged. There will be four classes: Spinnaker, Non Spinnaker, J22 One Design, and Family Cruising Class. To simplify the starting process, the Race Committee will announce on the Race Committee VHF channel the yachts which will start next. While all efforts will be made to inform all competitors of the starting order failure of a yacht to hear the announcement will not be grounds for protest.

5.3 The scheduled time of the warning signal for the race is 1200

#### 6 SAILING INSTRUCTIONS

The Sailing Instructions and Scratch Sheets including starting times will be available online at [Yacht Scoring.com](http://YachtScoring.com), passed out at the skippers meeting on Friday July 12, 2019, and available on Saturday July 13th at the registration desk located in the main room.

#### 7 VENUE

7.1 Attachment A shows the location of the racing areas.

The Narragansett Bay race area, with its East and West passages and approaches to Providence and Fall River, are considered a "restricted channel" for commercial traffic and vessels in the navigation channel, restricted in their ability to maneuver. Sailors must comply with the International COLREGS when in such proximity to commercial or privileged marine traffic. ## 8 THE COURSES

Yachts will rendezvous in the area 1 nm south of G'1' Fl G 2.5s Round Rock.

## 9 PENALTY SYSTEM

9.1 For all class(es) rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

9.3 Decisions of the protest committee will be final as provided in rule 70.5.

## 10 SCORING

Cruising Class Pursuit Race will have one (1) race.

## 11 BERTHING

For those yachts participating from yacht clubs outside of Greenwich Bay, moorings will be provided free of charge for both Friday, July 13th and Saturday July 14th in close proximity of EGYC on a first come first serve basis.

## 12 RADIO COMMUNICATION

All yachts, in addition to all federally required equipment, shall have a VHF radio aboard, and shall keep the radio energized on the Race Committee working channel VHF channel 74 from her "warning signal" until her "finish". Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

## 13 PRIZES

Prizes will be awarded to the first, second, and third place finishers in each class.

## 14 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

## 15 INSURANCE

Each participating boat shall be insured with valid third-party liability insurance.
