# Notice of Race



August 29 – September 1, 2019 Detroit, Michigan <sub>Hosted by</sub> The Cal-25 Club of Detroit Crescent Sail Yacht Club & Bayview Yacht Club



The notation "[DP]" in a rule in the NoR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.

# 1 Rules

The Regatta will be governed by the current Racing Rules of Sailing (RRS) and the Rules of the Cal 25 National Organization (V3.4.2 dated April 15, 2018). In addition, the Sailing Instructions will specify several Cal-25 Club of Detroit local rules which will apply.

- 1.1 **Crew Restrictions**. [DP] In addition to the restrictions in the Cal-25 National Rules, the crew for each race day shall be named on the Crew Declaration Form prior to the close of registration. The crew named must be carried on that race day except in the event of illness or other unforeseen circumstance, in which case the protest committee's written approval of a substitution must be obtained prior to the first race of the day in which the substitute is to compete.
- 1.2 **Motors**. Each boat shall carry an outboard motor with a minimum of 6 h.p. which shall be left on the transom at all times. One or more gas tanks may be stored any place on board.

# 2 Eligibility

The National Championship Regatta is open to all 2019 owner members of the Cal-25 National Organization which is comprised of local organizations located in Long Beach, Detroit, Port Huron and Annapolis.

Eligible boats may enter by completing the Yacht Scoring on-line form found on the Cal-25 website <u>http://www.cal25.org</u>, along with the required fees, by August 28.

- 2.1 Anyone who is not a member of a currently sanctioned local fleet, who wishes to compete, will need to contact the Race Chairman to request eligibility.
- 2.2 The helmsman must have been or be a titled owner of a Cal-25. The son, daughter, or spouse of a current owner is also eligible to drive.
- 2.3 No crew member shall be paid or receive compensation for participation in this event.

# 5 Measurement

Any sails measured and accepted/approved by one of the four currently sanctioned local fleets will be accepted for use in this regatta. Any sail(s) requiring measurement after 10 pm on Jul-31 will incur a \$10.00 measurement fee per sail.

#### 6 Sailing Instruction

Sailing Instructions will be available online via the Cal 25 National website and available during registration/check in.

#### 7 Racing Area

The race area will be on Lake St. Clair in close proximity to Crescent Sail Yacht Club.

# 8 Course

The courses will be windward-leeward.

#### 9 Scoring

In accordance with RRS appendix A2.1, there shall be no excluded races. One race is required to be completed to constitute a series.

# 10 Awards

The National Championship Regatta Perpetual Trophy will be awarded to the winning boat. Overall trophies for the top five finishers will be awarded Sunday, Sep 1st.

# 11 Disclaimer of Liability

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

#### 12 Insurance

Each participating boat shall be insured with valid third-party liability insurance with a minimum coverage of \$300,000 USD per event or the equivalent if expressed in other currency. Proof of insurance shall be provided upon request.
