

NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 Racing rule 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty. The changes will appear in full in the sailing instructions. The sailing instructions may also change other racing rules.
- 1.3 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing instructions, and supplementary sailing instructions that will be on the official notice board located at on the event web site.
- 1.4 Appendix T Arbitration will be in effect for this regatta.

2 ADVERTISING

2.1 Boats may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.

3 ELIGIBILITY AND ENTRY

- 3.1 The regatta is open to all Class A Scow boats that comply with NCASA specifications.
- 3.2 Eligible boats may enter by completing the form online at the event website or the Registration Form (Attachment B) and sending it, together with the required fee, to Todd R. Haines W330S 3000 County Road G, Dousman, WI 53118 by May 20, 2019.
- 3.3 Late entries will be accepted under the following conditions: After May 20, 2019 an additional late fee of \$100 shall be required.

- 5.2 Number of races: The series will be six (6) races.
- 5.3 The scheduled time of the warning signal for the each day is 1100.
- 7.6 On the last scheduled day of racing no warning signal will be made after 1300.

8 MEASUREMENT

8.1 Each boat shall have a valid weight certification sticker which is in the front of the cockpit under the mast. Any request for re-weighing must be done in advance, in accordance with NCASA policy.

9 SAILING INSTRUCTIONS

The sailing instructions will be available after June 1, 2019 on the event web site and at registration.

10 VENUE

10.1 The racing area will be the navigable waters of Lake Mendota.

11 PENALTY SYSTEM

11.1 RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty.

12 SCORING

12.1 One (1) race is required to be completed to constitute a series.

13 RADIO COMMUNICATION

13.1 The RC will use VHF radio to communicate to the fleet. Failure to make these broadcasts or failure to hear the broadcast shall not constitute grounds for granting redress. This changes rule 62.1.

13.2 Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

14 Berthing:

Limited Dry-sailing space will be available at UW Lot 60. A mooring mooring is available in the designated area. Provide your own mooring and ground tackle for 10-20' of depth. Taxi service to and fro will be provided. Trailer storage will be near UW Lot 60.

15 PRIZES

15.1 Prizes will be given as follows: Top ten (10) finishers, the top finisher of the hull built prior to 1999, and the top finisher of the hull prior to 2009.

15.2 Additional prizes may be given at the discretion of the organizing authority.

16 DISCLAIMER OF LIABILITY

16.1 Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

16.2 Liability Waiver Form – As a condition of entry, each owner, skipper and individual participating crew member shall sign a liability waiver/media release. The fully executed Liability Waiver Form shall be submitted at registration prior to racing or online at YachtScoring.com. By participating in this event, each competitor agrees to release the race organizers from any and all liability associated with such competitor's participation in this event to the fullest extent permitted by law.
