

# 62<sup>st</sup> ANNIVERSARY 2019 LAKE ERIE INTERCLUB CRUISE

June 22 - June 26, 2019

## NOTICE OF RACE

Organizing Authority: The Lake Erie Interclub Cruise, an association of representatives from each host.

**Hosts:** Buffalo Canoe Club, Buffalo Harbor Sailing Club, Buffalo Yacht Club, Erie Yacht Club, Port Dover Yacht Club, Dunkirk Yacht Club, Sugarloaf Sailing Club, Sugarloaf Harbor Marina

#### 1. RULES

- 1.1 The Lake Erie Interclub Cruise (Cruise) will be governed by the current Racing Rules of Sailing 2017 2020 (RRS)<sup>1</sup> and the following:
  - a. The prescriptions of the United States Sailing Association (US Sailing).
  - b. Applicable U.S. and Canadian governmental requirements.
  - c. The current PHRF-LE class rules.

# 2. ELIGIBILITY AND ENTRY

- 2.1 This event is open to members of US Sailing and Canadian Yachting Associations or other National Authorities, members of recognized yacht clubs, members of recognized sailing class associations, and others as may be designated by the Organizing Authority.
- 2.2 The Organizing Authority shall, at its sole discretion, and whose decision is final and without appeal, determine eligibility and placement within Divisions and Classes.
- 2.3 In order to be accepted, each registration must be complete, and include the entry form, a valid handicap certificate (or a temporary rating request see Section 4.2, below), proof of insurance (e.g., a declarations sheet), payment of the registration fee (and late fee, if applicable), and release of liability.
- 2.4 The deadline for completion of registration for all participants, including payment of entry fees, is 1700 hours, Friday, June 14, 2019. Registration can be made online at <a href="https://www.erieinterclub.com/">https://www.erieinterclub.com/</a>. Late registrations can be submitted until June 20, 2019 and must include the entry fee plus a late fee of \$75.00 (US).<sup>2</sup> Registration may be accepted on-site at the Erie Yacht Club on June 21, 2019 between 1700-1900 hours at the sole discretion of the Organizing Authority.

#### 3. INTERCLUB CRUISE FEES

- 3.1 The entry fee for all Racing Divisions is \$325.00.
- 3.2 The entry fee for a Cruising Division 3-day series is \$200.00.

# 4. CURRENT PHRF CERTIFICATE/ ADDITIONAL REQUIREMENTS

- 4.1 All Racing Division boats shall provide with their registration a copy of their current (2019 PHRF-LE) handicap certificate.
- 4.2 Racing Division boats without a current PHRF-LE certificate may be assigned a temporary rating at the sole discretion of the Organizing Authority, which shall be valid for the current year's Cruise only and cannot be appealed.
- 4.3 Boats participating in the Cruising Division will sail under PHRF-LE and will sail Jib and Main only and be scored as one class. The Organizing Authority will assign a handicap for any unrated boat, which shall be valid for the current year's Cruise only and cannot be appealed.
- 4.4 All boats must have on board a functional motor with means of mounting (for outboards) and carrying enough fuel capable of propelling the boat for a minimum of 50 miles.
- 4.5 All boats entering a race must have a minimum of two people on board for the duration of the Cruise.
- 4.6 All spinnakers, main sails, and headsails (larger than 130%) must have proper sail numbers. Boats without proper sail numbers or with duplicate sail numbers of another boat must notify the Race Committee Vessel (RC Vessel) prior to starting and upon finishing each race.
- 4.7 A boat and/or its equipment may be inspected by the Organizing Authority at any time for compliance with this Notice of Race and the Sailing Instructions.

## 5. SAFETY

- 5.1 All boats must meet the safety requirements of the US Sailing Safety Equipment Requirements (US SER 2018.0) for the Nearshore Category and any other requirements specifically identified in this Notice of Race or the Sailing Instructions.
- 5.2 All boats must carry equipment required by the State and Country of registration at all times.
- 5.3 Each competitor is individually responsible for his or her decisions to wear a personal flotation device and under what conditions.
- 5.4 All boats shall monitor VHF Race Channel 79 from the one-hour warning sound of a Racing or Cruising Division start and continue to monitor until all fleets have started. No signals will be displayed from ashore.
- 5.5 A boat that retires from a race shall notify the Race Committee either before leaving the course area via VHF Race Channel 79, or if that is impossible, immediately after arriving ashore by notifying the Race Committee.

#### 6. SAILING INSTRUCTIONS

6.1 Race packets including Sailing Instructions will be available on Friday, June 21, 2019 from 1700-1900 hours at the Erie Yacht Club.

# 7. IDENTIFICATION

- 7.1 Class flags, which will be provided in the race packets, must be flown on the backstay or other conspicuous position in the stern of the boat, and shall be displayed from the warning signal until the finish has been acknowledged.
- 7.2 Boats may fly the official Interclub Burgee during the Cruise on an appropriate staff or pennant halyard.

## 8. VENUE

8.1 All racing will take place on the open waters of eastern Lake Erie.

# 9. SCHEDULE OF RACES

Race 2	JUNE 23, 2019	ERIE TO PORT DOVER RACE (R) (C1)
Race 3	JUNE24, 2019	LONG POINT COURSE (R) (C1) (C2)
Race 4	JUNE 25, 2019	PORT DOVER TO PORT COLBORNE (R) (C2)
Race 5	JUNE 26, 2019	PORT COLBORNE TO POINT ABINO (R) (C2)

<sup>\* &</sup>quot;R" denotes the Racing Division; "C" denotes the Cruising Division (two 3-day events).

## 10. COURSES

- 10.1 The Racing Division (R) will sail five Races as defined in the Sailing Instructions.
- 10.2 Depending on entries, the Cruising Division will sail two separate 3-day race series (C1) or (C2) as listed below. Payment of the \$200 entry fee allows for a boat to sail in only one 3-day event.
  - (C1) June 22, 2019: Erie Course Race
    (C1) June 24, 2019: Erie to Port Dover
    (C1) (C2) June 25, 2019: Long Point Bay Course Race
    (C2) June 26, 2019: Port Dover to Port Colborne
    (C2) June 27, 2019: Port Colborne to Point Abino

# 11. SCORING

- 11.1 The scoring system of Appendix A will be used, except as modified below.
- 11.2 One race is required to be completed to constitute a series.
- 11.3 RRS A4.2 is modified as follows:

Position	Points
RET (Retired After Finishing)	(Finishers + 2) Pts
DNS (Did Not Start)	(Class + 4) Pts
OCS (On Course Side)	(Class + 2) Pts
DSQ (Disqualified)	(Class + 6) Pts
DNE (Disqualification not Excludable)	(Class + 8) Pts
DNF (Did Not Finish)	(Finishers + 2) Pts
DNC (Did Not Compete)	88 Pts

11.4 A boat's series score will be the total of all of her race scores. This modifies RRS A2.

#### 12. AWARDS

- 12.1 The Racing Division will have flags awarded for first, second, and third place finishes for each race.
- 12.2 The Racing Division will have flags awarded for overall first, second, and third place for the series.
- 12.3 The Interclub Trophy (Buffalo-Courier Express) will be awarded to the best overall boat in the Racing Division.
- 12.4 Prizes will be awarded to the top three boats for each 3-day Cruising Division series at the conclusion of each 3-day series. The Founder's Trophy will be awarded to the winning boat of the Erie to Port Dover Race on June 24.

#### 13. DOCKAGE

- 13.1 Dockage will be available only to those who have completed registration for the Cruise. This dockage will be provided by the Erie Yacht Club, Port Dover Yacht Club, Sugarloaf Sailing Club, and Buffalo Yacht Club based on availability at the time of the Cruise and the finish of each race. Additional overflow dockage at the Port Dover Yacht Club will be available in the Commercial Basin on the east side as you enter the harbor. NOTE: All Cruising Division boats will be docked in the Commercial Basin.
- 13.2 Competitors shall follow the directions of the respective host Yacht Club Dock Master. Failure to comply with the directions of the Dock Masters and/or crew or organizers shall be grounds for protest and possible expulsion from the Cruise.

## 14. INSURANCE

14.1 Each participating boat shall be insured with valid, third-party insurance sufficient to cover liability for loss, damage, personal injury, or death. Proof of coverage is required for registration (see Section 2.3, above).

# 15. DISCLAIMER OF LIABILITY

15.1 Sailing is an activity that has an inherent risk of damage and injury. Competitors and other participants sailing in this event are participating entirely at their own risk (see RRS 4, Decision to Race). The race organizers (Organizing Authority, Race Committee, Protest Committee, Host Clubs, Sponsors, or any other Organization or Official) shall not be responsible for damage to any boat or other property or personal injury to any competitor or other participant, including but not limited to personal injury or death, sustained as a result of participating in this event. By participating in this event, each entrant agrees to release the race organizers from any and all liability associated with such entrant's participation in this event to the fullest extent permitted by law.

- 15.2 As used in this Notice of Race and the Sailing Instructions, the term "Person-in-Charge" means the person who is designated on the Entry Form as the Person-in-Charge, whether or not he or she is the boat owner.
- 15.3 The safety of a boat and its crew is the sole responsibility of the Person-in-Charge, who must assure that the boat is fully sound, thoroughly seaworthy, and sailed by an experienced crew who have undergone appropriate training and are physically fit to participate in all weather conditions. The Person-in-Charge must be satisfied with the soundness of the hull, spars, rigging, sails, and all gear. The Person-in-Charge must assure that all safety equipment is properly maintained and that the crew knows where it is kept and how it is to be used. The acceptance of a crew by the Person-In-Charge, the establishment of equipment or safety requirements by the Organizing Authority, or an inspection (or the non-inspection) of a boat by the Race Committee, shall not in any way limit or reduce the responsibility of the Person-in-Charge.

## 16. CONDUCT

16.1 The Person-In-Charge shall be responsible for the conduct of the crew before, during, and after each race. In the event of serious misconduct, destruction of property, or failure to comply with a request of the Race Committee, Cruise Chair, or instructions from the Dock Master or harbormaster in any Cruise port, the Race Committee or Cruise Chair may request that the Protest Committee resolve the issue in accordance with RRS 69.
