NOTICE OF RACE

1 RULES

1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing (RRS)*.

1.2 The following documents also govern the U.S. Para Sailing Championship:

1.2.1 The US Sailing Championship Conditions.

1.2.2 The U.S. Para Sailing Championship Conditions

1.2.3 The US Sailing Code of Conduct

1.2.4 US Sailing Regulations 10.

1.3 Sonar Class Association Appendix B – Alternative Rules will be in effect. In addition, whisker poles are allowed. Spinnaker poles are not permitted.

1.4 International 2.4 mR Appendix K class rules will apply.

1.5 Racing rules listed below will be changed as indicated.

1.5.1 The US Sailing Prescription to RRS 40 will not apply and the preamble to Part 4 will be changed to require PFD use, dock to dock. A U.S. Coast Guard approved personal flotation device, or in the case of overseas competitors, a personal flotation device approved by their Government's corresponding Maritime Authority, shall be worn, properly fastened, at all times, while launching and sailing, except while temporarily adding or removing clothing.

1.5.2 The first two sentences of RRS 44.1 are changed to: 'A boat may take a One-Turn Penalty when she may have broken one or more rules of Part 2 or RRS 31 in an incident while racing.'

1.5.3 The US Sailing Prescriptions to RRS 63.2 and 63.4 will not apply.

1.6 Appendix T shall apply.

- 1.7 In case of a conflict between Notice of Race and Sailing Instructions, the Sailing Instructions shall govern. This changes RRS 63.7.

2 ADVERTISING

- 2.1 Advertising shall conform to the current World Sailing Regulation 20.
2.2 Boats may be required to display advertising chosen and supplied by the organizing authority in accordance with World Sailing Regulation 20.

3 ELIGIBILITY AND ENTRY

- 3.1 The Independence Cup competitors and boats.
- 3.1.1 The helmsman of each boat shall be a member of US Sailing or, if not a U.S. resident, the national sailing authority of their home country. Proof of membership will be required.
 - 3.1.2 Singlehanded Championship - 2.4mR: one person with or without a disability.
 - 3.1.3 Doublehanded Championship -Freedom Independence 20: two persons with disabilities.
 - 3.1.4 Triplehanded Championship- Sonar: three persons, with at least one with a disability.
- 3.2 The U.S. Para Sailing competitors and boats.
- 3.2.1 The competitors of each boat shall be members of US Sailing or, if not a U.S. resident, the national sailing authority of their home country. Proof of membership will be required.
 - 3.2.2 Singlehanded Championship - 2.4mR: one person with a disability.
 - 3.2.3 Doublehanded Championship -Freedom Independence 20: two persons with disabilities.
 - 3.2.4 Triplehanded Championship- Sonar: three persons with disabilities.
- 3.3 Doublehanded entries will be provided with an able-bodied (AB) person by the organizing authority and will perform non-tactical duties. AB sailors will rotate throughout the regatta as scheduled by the organizing authority (OA).
- 3.4 Eligible competitors may enter by completing the entry form linked to the Judd Goldman Adaptive Sailing Foundation (JGASF) website. www.JGASF@juddgoldmansailing.org
- 3.5 Competitors using equipment provided by JGASF shall:
- 3.5.1 Complete a Provided Sailboat and Equipment Agreement available on the JGASF website.
 - 3.5.2 Complete a Sailing Resume form available on the JGASF website, indicating racing experience, including experience in the intended race position, skipper or crew.
- 3.6 Competitor Eligibility for the U.S. Para Sailing Championship:
- 3.6.1 Competitors shall not use banned substances that would cause them to be declared ineligible under the rules and regulations of the US Anti-Doping Agency (www.usada.org), except under the terms of a valid Therapeutic Use Exemption (TUE). A copy of the TUE shall be provided to the OA.

- 3.6.2 No competitor shall use, at any time during the event, marijuana or any other controlled substance without a TUE. An alleged breach of NOR 3.6.1 or 3.6.2 shall not be grounds for a protest. However, if the protest committee believes that a competitor may have broken NOR 3.6.1 or 3.6.2, it shall follow the process described in US Sailing's Code of Conduct. A competitor found to have broken one of these rules shall be excluded from the remaining races of the series and, where practicable, removed from the regatta venue and sent home, and the competitor's boat (if not provided by the OA) shall be disqualified from all races of the series.
- 3.6.3 Classification is recommended but not required.

4 BOATS

- 4.1 Boats (2.4mR, Freedom Independence 20 and Sonar) with sails and appropriate adaptations are provided by the JGASF for competitor use. Competitors may also supply their own boat.
- 4.2 The organizing authority may require the JGASF provided boats to be rotated and such rotation may be listed daily.
- 4.3 All teams using boats provided by the JGASF shall post a damage deposit with the JGASF in the amount of \$500.00. This deposit will be collected by the JGASF at registration.

5 ENTRY FEES

- 5.1 Required entry fee per team for either one or both regattas is as follows:

7 SAILING INSTRUCTIONS

The sailing instructions will be provided at registration and will be posted on the regatta website. www.JGASF@juddgoldmansailing.org

8 VENUE

- 8.1 The regatta will be held at the Regatta Tent adjacent to the Judd Goldman Sailing Center at Burnham Harbor, 1362 S. Linn White Drive, east of the intersection of Lake Shore Drive and E. McFetridge Drive, Chicago, IL (one block west of the Adler Planetarium).
- 8.2 Racing will be on Lake Michigan, east of the Burnham Harbor entrance.

9 THE COURSES

The courses will be described in the sailing instructions.

10 SCORING

- 10.1 The Independence Cup Regatta and U.S. Para Sailing Championship competitors will sail and be scored together. All entrants will be competing in their respective classes for the Independence Cup Awards. For the U.S. Para Sailing Championship, the eligible entrants will compete for the awards in their respective classes.
- 10.2 One race is required to be completed by a class to constitute a regatta.
- 10.3 When fewer than six races have been completed, a team's score will be the total of their race scores. When six or more races have been completed, a team's score will be the total of their race scores excluding the worst score.

11 BERTHING

All boats shall be kept at the Burnham Harbor docks as directed by regatta officials.

12 HAUL-OUT RESTRICTIONS

Boats shall not be hauled out during the regatta except with and according to the terms of prior written permission of the race committee.

13 RADIO COMMUNICATION

While racing, and except in an emergency, or as directed by the race committee, a boat shall neither make nor receive transmissions by radio, mobile telephones or other electronic devices that are not available to all boats.

14 PRIZES

- 14.1 The Independence Cup awards will be presented to the first, second and third place teams in each class at the conclusion of racing on Sunday, July 28, 2019.
 - 14.1.1 The winning competitor in the 2.4mR class will receive the Independence Cup Singlehanded Trophy, which will be appropriately engraved and will remain on display at the JGASF.
 - 14.1.2 The winning team in the Freedom Independence 20 class will receive the Independence Cup Doublehanded Trophy, which will be appropriately engraved and will remain on display at the JGASF.

- 14.1.3 The winning team in the Sonar class will receive the Independence Cup Triplehanded Trophy, which will be appropriately engraved and will remain on display at the JGASF.
 - 14.1.4 The Kristi Walker Sportsmanship Trophy will be awarded to the regatta participant who best exemplifies the ideals of good sportsmanship both on and off the water during the regatta, as determined by the regatta competitors. The trophy will be appropriately engraved and will remain on display at the JGASF.
 - 14.1.5 The Pete Paganis/Bill Parks Most Improved Trophy will be awarded to the team or individual who, in the opinion of the regatta committee, comes to the regatta with the least amount of sailing experience and gives the best overall performance. The trophy will be appropriately engraved and will remain on display at the JGASF.
- 14.2 The U.S. Para Sailing Championship awards will be presented to the first, second and third place teams in each class at the conclusion of racing on Sunday, July 28, 2019:
- 14.2.1 US Sailing medals will be awarded in all divisions for the top three boats.
 - 14.2.2 The winner of the singlehanded class will be awarded the Judd Goldman Trophy.
 - 14.2.3 The highest placing singlehanded U.S. finisher will receive the title U.S. Para Sailing Singlehanded Champion.
 - 14.2.4 The winner of the doublehanded class will be awarded the Chandler Hovey Trophy.
 - 14.2.5 The highest placing doubledhanded U.S. finisher will received the title U.S. Para Sailing Doublehanded Champion.
 - 14.2.6 The winner of the triplehanded class will be awarded the Gene Hinkel Trophy.
 - 14.2.7 The highest placing triplehanded U.S. finisher will receive the title U.S. Para Sailing Triplehanded Champion.

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The JGASF and US Sailing and their officers, directors and employees, the event volunteers and officials, the event sponsors, and any other members of the regatta will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta. A waiver shall be signed by all competitors and shall be considered one of the documents governing the regatta.
