2. THE COURSE

The distance of the course is 47.5 NM.

Approximately 255° T

2.1. STARTING LINE

Between an orange tetra and the orange flag on the RC boat; an extended line with a yellow tetra may be used for the T10 start outside the St Joseph Harbor entrance. If a guard mark is set near RC boat; yachts may not pass between the guard mark and RC boat

3. THE FINISH

- 3.1 Whenever a RC boat is not on station at the finish line, finishing yachts shall follow the procedure outlined in the US Sailing prescription to RRS 34 as modified. The last sentence of the US Sailing prescription to RRS 34 is modified to read:

If a boat finishes when race committee is absent, to be scored as finishing she shall

- 1. Note her finishing time. The finish time shall be the GPS CDT time when the alternate finish line is crossed*

2. *Notify the RC, on Channel 78, of their finish time (GPS CDT time) as soon as practical after finishing". If no response, call: Janet Hansen at 773-233-5520 If no response, text information to 773-233-5520 or email to jpyc.race@gmail.com no later than 1200 09/02/2019.*

3. *if there is no longer an established finish line, it shall be a line of Longitude bounded by two lines of Latitude as follows: Longitude - W 087 ° 32.38, Latitude - N 41 ° 54.33 and N 41 ° 54.43. The finish time shall be the GPS time shown when the finish line is crossed.*

- 3.2 Unless conditions make it unsafe, the committee boat will stay on station until 2230 hours CDT on 9/1/2019. After that time, please take your finish time with the boat in front and boat behind and text information to 773-233-5520 or email to jpyc.race@gmail.com no later than 1200 9/2/2019.

4. TIME LIMIT

The time limit shall be 0300 hours CDT 9/2/2018 plus the amount of any postponement time applicable to a yacht's class. This changes RRS 35.
